
Main governmental body responsible for environmental issues

## Forests as of Today



Since the turn of the 19th century, Armenia witnessed a dramatic plunge in forest cover from 25 percent of its territory to the current low, estimated at 8-9 percent.

#### **Armenian Forest Services**

- The management of forest lands under supervision of "Hayantar" is 342,400 ha, of which 277,100 ha is covered by trees. This is approximately 75% of forests in Armenia.
- Areas under management of seven national parks is 300,000 ha, of which 55,000 ha is covered by trees. This is approximately25% of forests in Armenia.
- Hayantar has branches in different states.
- Main tree types are: oak, beech, hornbeam, pine.
- From 2012-2017 Hayantar has planted 1500 ha from which 647 ha were new forests and 853 ha were reforestation.

Priorities of the Armenian government is the **preservation**, **protection**, and **reproduction** of forests

### **Deforestation Reasons**


The following are some of the key drivers of deforestation in Armenia:

- The best trees are cut illegally for commercial purposes, such as construction, furniture making, and export
- Grazing of livestock in forest areas prevents regeneration
- Lack of education and awareness of the forest's value
- Lack of community ownership and responsibility for forests
- Lack of sustainable forest management practices

## Dilijan National Park


#### Major issue with illegal logging

Will be developing a special software to manage legal firewood



## Reforestation Programs

 UNDP - Implementation of sustainable land management and landscaping in mountainous landscapes of northeastern Armenia – Estimated planting 4,932 ha in 2018 and 2019

- IFAD Sustainable Land Management for Increased Productivity in Armenia – planting trees in 800 ha of degraded lands
- UNDP Forest Fire Prevention Project
- FAO/GCF Forest resilience of Armenia, enhancing adaptation and rural green growth via mitigation (at the proposal stage) – Planting to plant trees at 5,000 ha
- ATP A Diaspora NGO that has planted approximately 5,500,000 trees since 1994





### Plans for Forest Fire Prevention

- Creating 20 fast response teams (now there are only 3)
- Providing firefighting training
- Building small water reservoirs at high elevations
- Updating management plans

#### **Funds secured:**

- \$1 million from Russia
- €100,000 from CNF
