Provisions concerning sizing


Size is determined by the maximum diameter of the equatorial section.

The minimum size shall be 40 mm.

To ensure uniformity in size, the range in size between produce in the same package shall not exceed:


- 5 mm for fruit packed in rows and layers
- 10 mm for fruit loose packed in the package.





Remarks on the test

- When sizing is done manually, uniformity demand 5 mm can be difficult to fulfill (see orange line)
- Difference weight/content per box in weight is large (1097-1316 gram = 19 % in weight)
- At customs a declaration is done per kilogram (importduty)

Market demands

- Figs are more popular and sold in retail shops loose or prepacked and are sold either with price per piece, per packaging or per kilogram
- Importers buying the figs per piece (amount per box) and selling per kg to retailers
- Retailers are obliged to present a kilo price at figs sold per piece
- Some producing countries have possibilities to sort and grade per weight instead of per piece



Adjustment

Provisions concerning sizing (Section III)

Size is determined by the maximum diameter of the equatorial section.

The minimum size shall be 40 mm.

To ensure uniformity in size, the range in size between produce in the same package shall not exceed:

FOR FIGS PACKED BY DIAMETER

- 5 mm for fruit packed in rows and layers
- 10 mm for fruit loose packed in the package

FOR FIGS PACKED BY WEIGHT:

- xx g where the heaviest piece weighs xx g or less

Adjustment

D. Commercial specifications

- Class
- Size, expressed as minimum and maximum diameters, or minimum and maximum weight
- Number of fruit (optional)



Results (no obligation, optional to adjust in producing countries)

- At farmlevel: if sorted and graded by weight a better price
- Option for a reduction of the logistical commodities (now e.g. 14, 16,18,20,22,25 per box = 6 logistical items; packing by weight can reduce to 5 or less ?)
- Less calculations in logistic chain: at trade level or retail level
- Better options to pre-pack and sell per kilogram = transparency



Next step

Starting point: uniformity should be kept in a proper manner

Do some tests to set the min and max weights in the proposed adjustments
