#### **4. Standard Layout for United Nations Economic Commission for Europe Standards for Fresh Fruit and Vegetables**

The Specialized Section is invited to continue the review of the Standard Layout and discuss proposed topics including, among others, increasing the total tolerance allowed within Class II tolerances; uniformity in size when size is done by count as well as the use of size indication (metric/imperial).

## **5. Sustainable Development Goal 12 and sustainable practices: food loss and food waste**

Under the topic of Sustainable Development Goal 12, the leader of the working group (Germany) will present the revised draft minimum marketing quality guidelines for review and discussion by the Specialized Section.

The Specialized Section is also invited to discuss a proposal to add provisions to the adopted UNECE Code of Good Practice to help guide and ensure quality along the marketing and supply chain in lesser developed countries.

The secretariat will provide an update of activities related to the work of the Working Party and the secretariat on food loss and waste.

The delegation from the Netherlands will introduce for discussion the topic of possible involvement of retail/supermarket organizations at the international level in the debate on lowering requirements (often stricter than public and others) and reducing food loss and waste.
