

# 6. Sampling plan for tree nuts and dried produce and guidelines for inspections of dry and dried produce

At its 2018 session, the Specialized Section decided to organize a second working session to validate the sampling plan developed in Izmir, Turkey, in November 2018. It was also

decided that once the plan had been finalized, it would be useful to organize a training workshop for a larger audience, and to produce written guidelines and a video. The Specialized Section is invited to discuss the finalized plan; the organization of a workshop and development of guidance material.

#### 7. Revision of the Standard Layout

#### (e) Cashew nuts – explanatory guide and cashew kernel colour chart

At its 2018 session, the Specialized Section decided to develop an explanatory guide for cashew nuts as well as a cashew kernel colour chart. The Specialized Section is invited to discuss the drafts.
