# The Workshop

The United Nations Conference on Trade and Development (UNCTAD) and United Nations Economic Commission for Europe's Centre for Trade Facilitation and Electronic Business (UN/CEFACT) are organizing a two-day workshop to strengthen the work of national and regional trade facilitation bodies.

Trade facilitation bodies can play an important role in helping countries simplify and standardize their trade procedures and trade information flows. By involving all stakeholders (private and public) in the design and implementation of trade facilitation measures, they help to ensure that the trade facilitation needs are properly identified and that the proposed solutions are effective.

However, not all countries have a well-functioning national trade facilitation "platform". Nor are all trade facilitations bodies equally successful in their work.

The workshop aims to identify best practices in establishing effective national and regional trade facilitation bodies and ensuring their sustainability. It will highlight the needs and main challenges in facilitating trade at the national and regional level. It will also present the latest developments in trade facilitation tools and instruments.

This workshop forms part of the UNCTAD technical assistance project "Support to trade facilitation platforms in developing countries", which is funded by the Government of Sweden.

## What will be covered

# Day 1: National and Regional Trade Facilitation Bodies: country's experiences

Day one will include presentations by several trade facilitation organizations, which will describe:

- Their organizational aspects
- Mandate and main goals
- Financing
- Main activities
- Lessons learned.

Interactive discussion sessions will be held in the second part of the day to allow participants express their views and share their experiences on what works and what does not work in practice. Outcomes of the discussions will be presented at the beginning of Day two.

# Day 2: Facilitating trade in the changing environment

Day two will focus on the international context of trade facilitation activities.

During the morning session, experts from international organizations will describe what trade facilitation tools and instruments they can make available to trade facilitation bodies.

In the afternoon, a panel composed of representatives of trade facilitation bodies and international organizations will discuss the role of these bodies in the current trade facilitation environment, especially in the light of the negotiations at the World Trade Organization.

# **Speakers**

Speakers will include representatives of national and regional trade facilitation bodies, and experts in trade facilitation trends and techniques from UNECE, UN/CEFACT, UNCTAD and the World Bank.

#### Who should attend

The workshop is targeted at national and regional trade facilitation organizations.
