### ESTABLISHMENT OF MANDATORY REQUIREMENTS

**1** **only** by technical regulations  
of the Union

by the national legislation  
**before technical regulations of the  
Union come into force**

**ONLY** FOR PRODUCTS IN THE SINGLE LIST

EEC Council Decision  
№ 103  
of November 23, 2012

**2** NOT FOR PRODUCTS, NOT INCLUDED IN THE SINGLE LIST

FROM THE DATE OF ENFORCEMENT OF THE UNION'S TECHNICAL  
REGULATIONS **mandatory requirements established earlier:**

**apply** through transitional provisions

**do not apply** from the date of  
termination of the transitional  
provisions
