## Report of the Advisory Group on Market Surveillance on its activities and its meetings

Submitted by the secretariat

### *Summary*

The report of the meeting of the “MARS” Group, held in Prague, Czech Republic, from 24 to 25 June 2015, is hereby submitted for adoption by the Working Party.

The main decisions taken were: to continue the development of the general market surveillance initiative and cooperation with other groups under the umbrella of the WP6 (prepared the inputs into market surveillance guidelines has been developed by SIEEE), to enhance activities related to cooperation between market surveillance authorities (MSA) and customs authorities, updating MARS global database of MSAs and establish contact between global and regional Market Surveillance Networks; to support MSAs and explore the possibility for training market surveillance authorities on issues related to counterfeit goods, product marks and on-line Market Surveillance.

## I. Introduction

1. The 13th MARS-meeting was co-organized by UNECE and by the Ministry of Industry of the Czech Republic and the Czech Office for Standards, Metrology and Testing.



2. The meeting was attended by 23 experts from nine UNECE member countries, the European Commission and the Eurasian Economic Commission representing different organizations and stakeholders.

4. The Deputy Minister, Czech Ministry of Industry and Trade and the President of Czech Office for Standards, Metrology and Testing opened the meeting.
5. The WP.6 Chairperson recalled the MARS Group work plan, developed and endorsed at the 24<sup>th</sup> Session of the Working Party in November 2015. This work plan would guide the discussions of the MARS Group meeting. The Chairperson of the MARS group introduced the meeting agenda. She emphasized the role of the MARS group in promoting cooperation among market surveillance authorities (MSAs) and between MSAs and economic operators and increasing transparency, identifying good practices and fulfilling legitimate responsibilities.
6. The WP.6 Secretary presented the main conclusions of the previous MARS Group meeting and intersessional developments.

## **II. Challenges and resources available to MSAs**

7. The EC representative presented the challenges of e-commerce for product safety in the context of the New Approach. A report on online market surveillance best practices is available at [http://ec.europa.eu/growth/single-market/goods/building-blocks/market-surveillance/organisation/index\\_en.htm](http://ec.europa.eu/growth/single-market/goods/building-blocks/market-surveillance/organisation/index_en.htm) and an online working group had been established. Detailed guidelines for MSAs were under development and will be made available in due time.
8. Answering a question from the floor the EC representative explained that the group had been formed and action plans and guidelines on how to collect online information had been developed: the website would be kept up to date as discussions progressed. The WP. 6 Secretary asked for examples of best practices in EU member states. The speaker pointed to the Netherlands where legal responsibilities are clearly defined and authorities were moving rapidly forward in this area.
9. The Swedish representative presented a mapping of other MS networks. This activity had been undertaken as part of the MARS work plan adopted at the last WP. 6 session, to address the identified need to increase a more global attendance in the UNECE MARS group. The full table is available as Annex A to this report. She encouraged participants to provide more input into the list and requested the secretariat to establish contact with some of the listed regional and global networks and invite them to the next WP. 6 meetings and future UNECE MARS meetings (e.g. OECD WP, International Consumer Product Safety Caucus, Organisation of American States, Ibero American Forum of Consumer Governmental Agencies, African Dialogue on Consumer Protection, ASEAN and APEC). As for European forums, the group already had good and existing relations.
10. The representative of the UK presented his country's experience in promoting cooperation between MSAs and businesses. His agency had established a single point of contact with each major company. He suggested that this experience could be replicated in other countries. His agency was also developing a code of good practice for consumers. He concluded by presenting an example on how partnerships with businesses on specific product (e.g. electric blankets) could result in increased visibility of MSAs and intelligence about dangerous products. Answering questions from the floor, he gave further information on the UK MSAs structure and working methods.

11. The secretariat presented templates for exchanging information among MSAs that had been prepared by the EC and invited the participants to comment on and adapt the document as needed until mid-August. The templates are available as annex to the current report.

12. The secretariat recalled that the database of MS authorities is still available at the WP.6 website (<http://www.unece.org/trade/wp6/marsdbase.html>) and is urgently in need of updating. She invited the participants to update the information therein as needed until mid-August. The issue will be revisited in cooperation with the European Commission representative.

13. Participants discussed the proposal of the coordinator of General MS initiative to develop standards for MS requirements within European standardization bodies. Participants were of the opinion that these bodies would not be the right forum for the discussion, and that the MARS Group was ill-suited to propose topics of work for these bodies. The EC representative promised to return to this matter after consultations with his colleagues.

### **III. Experiences of national and regional MS developments**

13. The expert from the Czech Republic presented the activities of its Trade Inspection Authority on international cooperation. She presented the joint actions undertaken during 2013 and 2014 and the different networks with which the authority cooperated.

14. The representative of Eurasian Economic Commission outlined the principals, goals and objectives of MS in the Eurasian Economic Union. Member countries were in the process of establishing an international treaty on harmonization of the legislation in the field of state control. The treaty will aim at coordinated approaches in conducting checks and facilitating effective exchange of information between the competent authorities. 15. The MARS Group Chair presented the management information system of the Serbian MSA. She said that following the implementation of this system the inspectors use only one software that integrates several different databases. One of these databases includes information on the enforcement of intellectual property rights. Answering questions from the floor, she explained that regional cooperation with other South East European countries had been supported by an EU project which had recently concluded. A new SIDA funded project would start in the near future and include Turkey in addition to already participating countries. The project would focus more on quality infrastructure than on market surveillance.

16. The representative of Romania presented in detail the main changes to the Blue Guide that had been re-published in 2014 after a comprehensive revision. It was issued to take into account new developments since the previous edition in 2000, in particular, the New Legislative Framework and the Lisbon Treaty. The new Blue Guide is a living document, and is available in English on the European Union's website <http://ec.europa.eu/DocsRoom/documents/4942>. The representative of Sweden summarized the comments that her delegation had sent to the EU Commission on the Blue Guide revision.

17. Experts then discussed the 2014 ATEX Directive (2014/34/). The MARS Chair explained that the current version of "Guidelines on implementation" had been issued on the basis of the previous version of the directive. New guidelines were in the process of being prepared. In Serbia, the previous version of the directive had been transposed into national legislation, and guidance had been prepared on its implementation. There was a proposal to include this sector in the annual market surveillance plan. She explained how

responsibilities were divided among different authorities in her country and invited participants to share their national experience and any checklist that they may have developed.

18. The representative of Sweden said that checklists had been drafted by DG TAXUD and implemented by member states. The Chair asked the European Commission representative to see if these checklists could be shared. The representative of Turkey used different checklists for inspectors. The UNECE said the Sectoral Initiative on Environments with an Explosive Atmosphere (SIEEE) also under the umbrella of the WP. 6 had requested the MARS Group inputs into the revision of the Market Surveillance guidelines that it had developed. Experts asked the secretariat to share the document with them so as to give their input.

19. The representative of the Legislation Department of the Czech Office of Standards, Metrology and Testing introduced a recent development in preparation of the Act on “Conformity Assessment and Market Surveillance”. This Act will replace a previous law, dating from before the entry into force of the New Legislative framework. He explained that the new act will create a legal framework tailored specifically for the implementation of EU legal instruments, in particular laying out the responsibilities of national administration and authorities - however the old law will remain in force for the non-harmonized areas.

20. The representative of the Czech Consumer Association presented an example of cooperation between consumers and market surveillance authorities on the safety of playgrounds. In this sector, the Czech MSAs do not have competency for inspections, and conformity assessment is only compulsory *before* placing the equipment on the market. Check have shown that close to a third of playgrounds are not in compliance with the standard, so the consumer association has published a Guide to Good Practice and is promoting yearly voluntary inspections. Answering a question from the floor the expert said that databases on children’s injuries were available but were not comprehensive and efforts were underway to compile such databases at the EU level.

21. The meeting then discussed the planning of the next WP6 Plenary, which was going to take place back to back to a World Standards Cooperation event on conformity assessment. The secretariat invited experts to propose speakers and topics for discussion.

22. Discussions on the venue and dates of the next meeting would continue inter-sessionally.

#### **IV. Conclusions**

23. The Chair of the MARS Group concluded by thanking the hosts and all speakers and participants.
