
Annotated provisional agenda for the Informal Virtual Consultations^{*}

4. Virtual Conference on Building Back Better: Shared solutions as a Critical Tool for Sustainable Development in the Era of COVID-19

4. In the context of the global health crisis, quality infrastructure has helped to meet the negative effects of contagion and underpinned efforts to deliver continuity in trade. The session will invite delegations to a mini Conference on the solutions that internationally agreed standards can provide for quality infrastructure in support of member States' efforts to mitigate the impact of the recent crisis under the Building Back Better umbrella. Discussants will consider how quality infrastructure helps to meet the myriad challenges of the pandemic and support member States to meet societal needs; both by alleviating trade disruptions and improving the adoption of internationally harmonised policies and regulations.

5. Infrastructure covers most of the operational areas of WP.6 including standards, technical regulations, accreditation, conformity assessments, market surveillance and metrology. These areas can provide significant support to recovery from the COVID-19 pandemic and strengthen resilience to future crises. The mini conference will address the ways in which WP.6 contributes to strengthening resilience of member States to future crisis events. These also include how women's participation in international standard-setting is in the forefront for response to the pandemic through driving economic strength on the ground; by sharing recent experiences in the need for reliable, fast and effective conformity assessment shown in the examples of masks, personal protective equipment etc. as opposed related to challenges in developing countries, counterfeit, and testing kits.
