**LISTING, CLASSIFICATION AND PACKING**

**Requirements for Toxic by Inhalation Liquids**

**Transmitted by the expert from the United States of America\***

1. At its thirtieth session, the Sub-Committee considered a proposal regarding portable tank assignments for toxic by inhalation liquids (ST/SG/AC.10/C.3/2006/93). This proposal was adopted as amended by several informal documents submitted during the same session (see UN/SCETDG/30/INF.73, INF.74, and INF.75) and resulted in amended portable tank assignments for a number of toxic by inhalation liquids.
2. During discussions on this issue, it was noted by the Sub-Committee that consequential amendments to the dangerous goods list were in order. In particular, it was noted that a number of materials whose portable tank assignment had been amended to be "T20" were still assigned to P001. It was agreed that further amendments to the dangerous goods list were necessary to ensure the packing instruction assignments in Column (8) were consistent with assignments for other toxic by inhalation liquids and with the application of the Guiding Principles. The present proposal is to make such appropriate amendments to the dangerous goods list by replacing

packing instruction “P001” with packing instruction “P602” for the toxic by inhalation liquids whose tank assignments were amended during the 30<sup>th</sup> session. The inhalation toxicity data for the materials in this proposal were previously submitted in informal document UN/SCETDG/30/INF.75.

### Proposal

3. Amend column (8) of the Dangerous Goods List by replacing “P001” with “P602” for the following toxic by inhalation liquids:
