### **ACTIVITIES:**



Outcome: documents for the sessions of the SC.3/WP.3 and SC.3 Working Parties

- **2. TOPIC:** Proposals for means and measures to make the profession of boatmaster and other crew members employed in inland navigation more attractive and to bring these professions in line with modern requirements.
  - $\underline{2.1}$  Preparation of a document on the general policy topic "Making jobs of crew members employed in inland navigation more attractive" for  $58^{th}$  session of SC.3

Outcome: document on the theme

TOPIC: Analysis of existing national, regional and international instruments and preparation of proposals aimed at further harmonizing mutual recognition and modernization of professional qualifications in inland navigation at the pan-European level on the basis of existing SC.3 resolutions. Elaboration of minimum manning requirements for each type of vessel, and of required competencies for crew members based on new generations of inland navigation vessels and equipment.

Terms of execution: to be decided

3.2.2 Making a draft proposal of revised Chapter 23 or a new document to be adopted by SC.3 on the basis of the analysis of the existing instruments and revision of existing Chapter 23, including minimum manning requirements for each type of vessel, and of required competencies for crew members based on new generations of inland navigation vessels and equipment

Outcome: a revised draft of Chapter 23 or of new UNECE document
