### **2. Programme of Work: Taking Stock of National Legislation**

#### **(a) Sign to communicate the need to crash through gates (barriers) by a vehicle when trapped at a level crossing**

The Group of Experts agreed at its sixteenth session on a crash through gates (barriers) sign. This sign should be included in the convention as G, 24 sign together with relevant provisions on this sign placement as well as the use of an additional panel and its placement. The Group of Experts will be invited to review the provisions developed for this sign and included in ECE/TRANS/WP.1/GE.2/2018/4/Rev.1.

#### **(b) Review of recommendations on A through F signs**

The Group of Experts is invited to review its recommendations made at earlier sessions for A through F signs. This review is to be facilitated through Informal document No. 4 (February 2018) which lists issues formulated on the basis of responses to ECE/TRANS/WP.1/GE.2/2018/1, section A through F. At the current session the Group of Experts will start from point 64 of the document.

The Group of Experts will be further invited to discuss comments to ECE/TRANS/WP.1/GE.2/2018/4/Rev.1 suggesting amendments to Annexes 1 and 3 of the convention. Informal document No. 1 updating the Informal document No.1 of September 2018 - consolidating comments from experts - is to facilitate this discussion. At the sixteenth session comments provided to D section signs and to A, 12/E, 12 signs were discussed, and relevant changes were reflected in ECE/TRANS/WP.1/GE.2/2018/4/Rev.1.

The Group of Experts is also expected to conclude on the depiction of symbols for motorcycle and moped and for pedestrian crossing. The secretariat's proposal to changing the sign name coding should be discussed.

Finally, the Group of Experts is invited to examine and possibly finalise its draft final report on the review of the convention's signs (ECE/TRANS/WP.1/GE.2/2018/5). When doing so,

the Group of Experts should consider preliminary comments and feedback, if any, from the Global Forum for Road Traffic Safety (WP.1).
