

Problems addressed by the DANrISS Project



Identified need for improving the efficiency in the cross-border coordination context between the two responsible administrations EAMA and RNA:

- **Lack of information exchange** between EAMA and RNA on the performed inspections to ships visiting ports in the area of inland waterways and ships in the shipping line Romania-Bulgaria;
- **Lack of communication** between the two public institutions regarding the Notices related to changes in navigational conditions and special temporary regulations.



Activity 4

Present situation addressed by Activity 4

- There are **no developed common procedures** between the two responsible national authorities **for the inspections performed under the river supervision regime** in the common Bulgarian-Romanian stretch of the Danube river.
- Each performed inspection requires **allocation of human resources, financial resources and time**. The competent authorities on both sides of the river often **duplicate efforts for obtaining the same information**.
- All of the above also **reflects on the business**, requiring **additional time and resources**, due to the fact that its representatives are subjected to same procedures twice.

- Performed analysis of international regulations and corresponding national legislation

- The obtained results were analyzed, conclusions were formed and the text of the Agreement was drafted

For the purpose of the Activity, the two partners carried out review of:

- The legislation, regulating international and domestic navigation;
- The respective national legislation;
- The Specific/local rules on the safety of navigation applied in the section between river km 845.65 to km 374.1

As a result, Specific rules for the navigation in the common Bulgarian - Romanian stretch of the Danube river were drafted under the project.







Activity 7

Development of risk assessment methodology for river supervision inspections

- The developed methodology provides methods for calculation of risk mitigation in order to limit the number of hazardous situations.
- The prepared document is based on performed research on previous accidents on the Danube river and tracks the causal chain “risk of occurrence of navigational accidents” as method for identification, prevention and control of the risk of occurrence of possible accidents.
- The Methodology is complemented with features that justify the medium and long term strategic level of RIS for the formation of decisions to perform secure and efficient voyages.
- **The Methodology is incorporated in the Integrated System for Ships Inspection and serves for identification of the risk profile of the inspected ships.**
