## Evaluation by sub-project

RC	Evaluation
UNECA	The project greatly contributed to assess the region's capacity to undertake electronically custom to customs exchange thru comprehensive gap analysis for Mauritania, Tunisia, Morocco, Algeria. Technical assistance provided to UMA to engage its Member states using the prepared action plan to take steps for the implementation of electronic exchange. A technical platform developed and pilot experience with Agadir Countries being jointly experimented with ESCWA
UNECE	The project greatly contributed to starting the Georgia-Turkey eTIR pilot project. The protocol signed by ministers of both countries shows the importance of the project and will ensure its continuity. The technical assistance helped Georgian Customs to connect their IT system to the CEP.
UNECLAC	Through this project, the Central American region and Costa Rica in particular has increased its awareness on how the current Transport of International Merchandise (TIM) C2C electronic data exchange system can be improved in areas such as processing electronic import invoices and risk management.
UNESCAP	The project identified mutual interest of Kyrgyzstan and Tajikistan in the electronic exchange of data between Customs authorities. The roadmap for establishment of C2C electronic data exchange between Kyrgyzstan and Tajikistan was developed.
UNESCWA	The project contributed to the development of a platform to exchange data between the customs of Tunisia, Morocco, Egypt and Jordan through the Tunisian single trade window: Tunisia Trade Net. The platform has been finalized and its concrete application will depend on the decision of the four member countries of the Agadir declaration.
