# **DRAFT SCHEDULE: Review, inputs & feedback**



#### **DRAFTING & REFINING HANDBOOK CHAPTERS**

- Working Draft Chapters I, II, IV, V + Working Draft Chapters VI & VII + Working Draft Main Messages
  - **8 November 2020:** EG to provide responses by email to the Secretariat

#### **CASE STUDIES**

- October 2020: Submission of case studies: Urgent!
- November 2020 April 2021: Review of case studies & integration into the narrative of the Handbook
  - Secretariat will coordinate with designated focal points for review and approval for inclusion in the Annex

#### FIRST FULL DRAFT OF HANDBOOK TEXT

- **December 2020**: Each chapter is submitted by drafting team. Each reviewed, edited & collated by Secretariat.
- January 2021: Sent by Secretariat to the Expert Group & to national focal points to the Convention
  - February 2021: [4 weeks for review] Responses to be provided by email to the Secretariat

#### SECOND FULL DRAFT OF HANDBOOK TEXT INCLUDING CASE STUDIES

- March April 2021: Completed by the secretariat & submitted as an informal document to the IWRM WG
  - 26-28 April 2021: discussed & reviewed at IWRM WG, possible to submit feedback by 9 May 2021

# DRAFT SCHEDULE: Translation, Publication, Launch WATER CONVENTION

#### FINAL FULL DRAFT OF HANDBOOK TEXT INCLUDING CASE STUDIES

- 31 May 2021: Final draft submitted to the Bureau of Convention for final review and approval
  - Any final feedback would be incorporated into the final version in early June 2021

#### **TRANSLATION & DESIGN**

- June 2021
  - Translation of the Handbook into French, Spanish, Russian
  - Design elements for the publication completed for the Handbook

#### **SUBMISSION & PUBLICATION**

- July 2021: Publication finalized in all 4 languages in PDF Format
- 21 July 2021: Transboundary Water Allocation Handbook officially submitted to 9<sup>th</sup> MoP for adoption
- July-August 2021: Publication copies printed

#### **LAUNCH & ADOPTION**

• 29 Sept – 1 Oct 2021: Handbook is launched at the 9<sup>th</sup> MoP thereby tabled for discussion & adoption
