
### Revised annotated provisional agenda for the twelfth meeting

#### 2. Adoption of the report on the eleventh meeting of the Committee

2. The Committee will agree on the adoption of the report on its eleventh meeting (Geneva, 31 August–2 September 2020).

#### 3. Advisory procedure (closed)

Tentative timing: Thursday, 4 February, 11.15 a.m.–2 p.m. and 3–6 p.m., and Friday, 5 February, 11 a.m.–2 p.m. and 3–5 p.m.

- 3. The Committee will discuss information received since its eleventh meeting from Parties taking part in advisory procedure WAT/IC/AP/1. It will discuss and agree upon the format and objectives of the upcoming consultations with the delegations of Albania and Montenegro.
- 4. The Committee will hold consultations with the delegations of Albania and Montenegro jointly on the following issues:
- (a) Information provided by the countries in response to the additional questions for clarification formulated by the Committee after the eleventh meeting;
- (b) Any relevant developments related to the planned construction of additional small hydropower plants on the Cijevna/Cem River in Albania;
  - (c) Any relevant developments in bilateral cooperation between the two countries;
- (d) Scope of and modalities for possible assistance from the Committee in setting up a joint monitoring and assessment framework for surface waters, groundwaters and ecosystems in the Cijevna/Cem River basin;
- (e) Scope of and modalities for possible assistance from the Committee in facilitating the exchange of information related to the Cijevna/Cem River basin.
- 5. Following the consultations with the delegations of Albania and Montenegro, the Committee will discuss their outcomes and agree on the next steps and responsibilities.
