The 11<sup>th</sup> International Forum for Sustainable Energy in Georgia originally planned for September 2020, which was seen as the official launch opportunity for the final report, is also postponed to 2021.</p> <p>In consequence, it is now planned to launch the final report and further disseminate Pathways to Sustainable Energy, Phase I results at the 29<sup>th</sup> session of the Committee on Sustainable Energy on 25 November 2020 including with international press. This proposal was welcomed by the donors. The Bureau of the Committee has just approved this approach.</p>

However, this is subject to extrabudgetary funding and in-kind contributions. Fundraising will be actively sought during 2020. Resourcing strategy will be discussed with the Bureau of the Committee on Sustainable Energy in its calls and meetings in 2020. The Regional Advisor will also be involved.</p>	Ms. Stefanie Held, Chief of Section	December 2020	<p><b>In progress</b></p> <p>Several workshops had been planned in the Caucasus and Central Asia region with the focus on renewable energy and cost of electricity, as well as nexus areas energy and water. These have been postponed to 2020 when travelling will be possible again, and the secretariat is in contact with the donor (Russian Federation).</p> <p>The Regional Adviser has been supporting activities and it is planned to host capacity-building workshops during September and November energy meetings in Geneva, bringing in participants and experts from eligible countries to Geneva. The project team is seeking extrabudgetary and in-kind contributions to deliver more capacity-building activities in subregions. More clarity should be received in the Q4 2020.</p> <p>Interest for further capacity-building activities has been expressed also for Eastern and South-Eastern Europe.</p>

Concept ideas were presented to the UNECE Executive Committee in December 2019 and February 2020. SED is also encouraging active participation of female experts as key note speakers, moderators and panelists at expert groups and Committee on Sustainable Energy meetings.</p> <p>SED recently launched a project on “Enhancing the understanding of the implications and opportunities of moving to carbon neutrality in the ECE region across the power and energy intensive industries by 2050” under which it formed a Task Force on Carbon Neutrality. The team is striving to achieve active participation of female experts. Currently there are 60 policy makers and industry experts recruited in the Task Force on carbon neutrality, of which 37% female and 63% male.</p> <p>The project team is planning to recruit 2 female experts to the project Advisory Board. Currently the team is in discussion with one expert from Germany, one from Serbia and one from Russian Federation.</p>
