### Report on communication and outreach activities

This note provides an overview of communication and outreach activities carried out by the secretariat. 

Media impact of communication efforts around the 40th anniversary
In (web) media, there were 32 articles on the Air Convention. Of these, 21 were published in English,
7 in Russian, 3 in Italian and 1 in Chinese. Estimated total reach of the articles: 52,000,000

In terms of Twitter posts, there were 406 tweets (including retweets) related to the Air Convention. Of these, 396 were published in English, 4 in German, 2 in Spanish and 1 in French. Estimated total reach: 7,652,327.
