Resource Mobilization Action Plans 2020-2022

Note by the Secretariat

- 1. The Resource Mobilization Action Plans are submitted for information pursuant to the approval of the revised Resource Mobilisation Strategy by the Executive Committee (EXCOM) on 29 May 2020 (ECE/EX/2020/L.4).
- 2. The submission of the Action Plans also allows us to close the recommendation #1 of the Audit of the management of trust funds at the Economic Commission for Europe (OIOS 2018/084), which was formulated as follows: ECE should review its resource mobilization strategy and multi-year plan and take appropriate steps such as: (i) incorporating measurable and quantifiable performance indicators in the strategy; (ii) instituting a process to track the progress achieved; and (iii) including the impact of resource mobilization activities in its annual report to the Executive Committee.
- 3. Resource Mobilization Action Plans are presented for all subprogrammes and for the Office of the Executive Secretary, as well as for the four nexuses. In line with the approved Resource Mobilisation Strategy, the Secretariat will come back to EXCOM annually, to report on the implementation of the UNECE Resource Mobilisation Strategy, through the Technical Cooperation report.
- 4. The submission of these Resource Mobilisation Action Plans intends to increase the transparency of the Secretariat by highlighting where the main mobilisation efforts will be put in the next two years.
- 5. All activities presented are subject to donor interest and EXCOM approval, in line with the established regulations for approval of extrabudgetary funding.
- 6. Except for the Sustainable Use of Natural Resources nexus, the amounts reported under the other nexuses do not reflect the full potential of these high-impact areas where multiple Sustainable Development Goals converge. While UNECE intends to maintain its mobilization efforts in all nexuses in the coming years, a review will be undertaken in 2021 to assess the next steps towards further cross-sectoral collaboration.
- 7. The Secretariat invites member States to continue supporting the UNECE by providing additional resources for its mandated activities. The Secretariat also invites the Parties of the Conventions and Protocols to provide the financial and in-kind contributions required to implement the estimates, based on approved or expected workplan budgets.
- 8. The Secretariat of the multilateral environmental agreements also encourages the provision of financial resources in advance of or early in the workplan periods to enhance the predictability of financing and enable adequate planning for the implementation of workplan activities, including human resources.
