#### **II. Annotations**

The Task Force on Public Participation in Decision-Making was established, and its mandate laid down, by the Meeting of the Parties to the Convention at its resumed second extraordinary session (30 June 2010) (ECE/MP.PP/2010/2/Add.1, decision EMP.II/1)<sup>2</sup>. The mandate was further extended in time by the Meeting of the Parties to the Convention through decision VI/2 (ECE/MP.PP/2017/2/Add.1)<sup>3</sup> adopted at its sixth session (Budva, Montenegro, 11–14 September 2017). Paragraph 11 of decision VI/2 sets out the issues to be addressed by the Task Force.

The present meeting aims to provide a platform for discussing in greater details participation of vulnerable and marginalized groups in decision-making and will allow for exchange of practices that facilitate more effective public participation without entailing additional significant resources on the part of public authorities. The thematic focus of the meeting will be on decision-making in the extractive industries sector, energy and climate; and regarding emerging technologies.

The Task Force continues its work based on the outputs delivered at its previous meetings. The background material for the meeting will include relevant information derived from the 2017 national implementation reports<sup>4</sup>, the Synthesis report on the status of implementation of the Convention<sup>5</sup>, the Aarhus Convention Implementation Guide<sup>6</sup>, the Maastricht recommendations on promoting effective public participation in decision-making in environmental matters<sup>7</sup>, and relevant Compliance Committee findings of a systemic nature.

Due to travel restrictions linked to the COVID-19 pandemic, the meeting will be held in a hybrid format with remote and on-site participation. Owing to limited availability of interpretation for remote participation, the meeting will take place from 10.00 to 12.00 and from 14.00 to 16.00 on 1 March and from 10.00 to 12.00 on 2 March.
