

1. PINOASA Quarry

The surface of the existing Pinoasa Quarry is highlighted in the perimeter outlined in gray and shaded in gray.

The surface provided in the Environmental Agreement no. 3/27.01.2016 for the continuation of the works in Pinoasa Pit is a discontinuous surface located in 2 different zones on the map: one is highlighted in the northern part of the existing quarry, shaded in green, having the outline highlighted half in magenta and half in grey; the other one is located under the shaded surface called „Halda exterioara Valea Negomir” and is shaded in green having the outline highlighted in magenta.

The quarry is located on the administrative territory of Călnic, Fărcășești and Negomir Communes, Gorj county.

2. Tismana I and Tismana II Quarries

The surface of the existing Tismana I and Tismana II Quarries are highlighted in the red and grey shaded perimeter, with a red and a grey outline.

The surfaces provided in the Environmental Agreements no.5/18.12.2015 and no. 6/18.12.2015 for the continuation of the works are located in the southern part of the existing quarries and are shaded with green.

The quarries are located on the administrative territory of Călnic Commune, Gorj county.

3. Rosia Quarry

The surface of the existing Rosia Quarry is highlighted in the perimeter shaded in gray and having a gray outline, located on the map at the right of Pinoasa Quarry.

The surface provided in the Environmental Agreement no. 2/26.01.2016 for the continuation of the works is located in the western part of the existing quarry and is shaded with green.

The quarry is located on the administrative territory of Farcasesti Commune, Gorj county.

4. Cariera PESTEANA NORD

The surface of the existing Peșteana Quarry is highlighted in the perimeter shaded in gray having a gray outline.

The surface provided in the Environmental Agreement no. 8/15.06.2016 for the continuation of the works is located in the southern part of the existing quarry and is shaded with green, contour magenta, on the map this surface is interspersed between Pesteana Nord and Pesteana Sud quarry.

The quarry is located on the administrative territory of Bilteni, Plopsoru and Urdari Commune, Gorj county.

5. Cariera LUPOAIA

The surface of the existing Lupoia Quarry is highlighted in the perimeter shaded in gray with a gray and magenta outline. It is visible on the left side of the map.

The surface provided in the Environmental Agreement no. 4 / 19.04.2016 for the continuation of the works is located in the NW part of the existing quarry and is shaded with green, contour magenta.

The quarry is located on the administrative territory of Motru and Cătunele, Gorj County.

6. Cariera JILT NORD

The surface of the existing Jilt Nord Quarry is highlighted in the gray shaded perimeter with a gray and magenta outline.

The surface provided in the Environmental Agreement no. 06/09.05.2016 for the continuation of the works is located in the NW part of the existing quarry and is shaded with green, contour magenta.

The quarry is located on the administrative territory of Mătășari and Fărcășești Communes, jud. Gorj.

7. Cariera JILT SUD

The surface of the existing South Jilt Quarry is highlighted in the gray shaded perimeter with a gray outline.

The surface provided in the Environmental Agreement no. 12/09.12.2016 for the continuation of the works is discontinuous and is composed as follows:

- one surface is located on the territory of Slivilești Commune, it is located in the South part of the existing quarry and it is shaded with green, contour magenta, near CROICI.
- another surface is located on the administrative territory of Dragotești and Negomir communes, it is located to the East of the existing quarry, near „Halda exteriora Valea Negomir”, to the N-E of Dragotești locality, it is shaded with green, contour magenta.
- the third surface is located on the administrative territory of the communes of Fărcășești and Negomir, it is shaded with green, contour magenta, located between „ Halda exteriora Valea Bohorel” and „Halda exteriora Valea Negomir”.

The quarry is located on the administrative territory of the communes of Mătășari, Fărcășești, Slivilești, Dragotești and Negomir, Gorj County.

NOTE: On the attached map the purple color/mauve color (outline) represents the administrative boundary of the various communes.
