

## **C&I and National Forest Inventory**

 Forests satisfy a range of interests and demands, but conflicts can arise when there are competing expectations. National Forest Inventories (NFIs) deliver objective, reliable and representative information, that provide measures of the ecological, economic and socio-economic benefits of forests.



✓ For a forest policy to be effective, decisions about management of forest resources must be well-informed. Forest Policy and Management Support Information Systems (FPMSIS) help to gather forest information, making it accessible, informing decisions, monitoring results and modifying current policies.

✓ C&I for SFM were developed as tools for monitoring, assessment and reporting to demonstrate progress towards sustainable forest management. Providing information on aspects related to SFM for decision-making is therefore a vital function of C&I for SFM.


