Importance of recognition in relation to youth

Global Education is education that opens people's eyes and minds to the realities of the world and awakens them to bring about a world of greater justice, equity and human rights for all.

Global Education is understood to encompass
Development Education, Human Rights Education,
Education for Sustainable Development, Education
for Peace and Conflict Prevention and Intercultural
Education; being the global dimensions of Education
for Citizenship.

# Example of Youth Engagement: Ireland

The NYCI partnership GE/DEAR programme

- National Youth Council, particular youth organisations, NGDOs, Irish Aid, etc.
- Strong, coherent, strategic sector wide approach.
- Training, campaigns, awareness-raising, representation.
- Building GE/ESD into the heart of what it means to do youth work.
- Strong inter-ministerial support.
- Funding is crucial, if used strategically.



CODEV of the Ministers of Foreign Affairs of the EU February 2020 heard...

- Strong policy and provision and commitment by Member States and by the EU; and good policy learning between MS and with the Commission in GE/DEAR
- Progress made towards ensuring access to quality GE and DEAR for all people in Europe.
- Circa 150 million Euro dedicated funding from ODA annually at national level

Council of the European Union Conclusions on Youth, June 2020

The Council calls upon the Commission and the High Representative, in cooperation with the Member States ... to (support) work with, by and for youth in order to:

Enhance active global citizenship through strengthened global education, development education and awareness raising (DEAR) with youth including training, youth work activities and awareness-raising in human rights, sustainable development...
