

1. Adoption of the agenda

2. Matters arising since the last session

(a) United Nations, United Nations Economic Commission for Europe and subsidiary bodies

The secretariat will present recent matters arising from the United Nations, the United Nations Economic Commission for Europe (UNECE), the Steering Committee on Trade Capacity and Standards and the Working Party on Agricultural Quality Standards (WP.7) having an impact on the work of the Specialized Section.

Delegations are invited to report on national efforts and decide on the development of contributions by the Specialized Section related to policy advice, guidance and capacity building for the fruit and vegetable trade.

5. Micro, small and medium-sized enterprises and agricultural quality standards for resilient supply chains

6. Nexus of sustainable use of natural resources

7. Resilient food supply chains and post-COVID recovery

Delegation are invited to report on country-based approaches and discuss the development of contributions by the Specialized Section to guidance material for fruit and vegetable supply chains.

8. Analysis of the impact of agricultural quality standards on the trade of fruit and vegetables

The Specialized Section is invited to review a proposal to launch a UNECE-wide analysis to support data collection on impact and supply chain improvement measures related to the use of UNECE's agricultural quality standards.

9. Sustainable Development Goal 12 and sustainable practices: food loss and waste prevention related to standards

The Specialized Section is invited to discuss the launch of a country-based review of measures taken and a compilation of practical measures and tools for agricultural supply chains (especially fruit and vegetables) to prevent and avoid food loss and waste.

The Specialized Section is also invited to review a background report prepared by the secretariat on the possibility of a digital certification scheme of operators taking food loss and waste measures and decide on the establishment of an ad-hoc working group to explore the possible modalities of such a scheme.

The Specialized Section is also invited to take note of the extended Code of Good Practice for Reducing Food Loss in Handling Fruit and Vegetables developed over the past year by a working group led by the delegation of Sweden. The document is submitted for information only.

Pomegranates

The Specialized Section is invited to discuss the proposal by the delegation from Spain to develop a UNECE standard for pomegranates on the basis of a review of the current Codex Standard.
