Introduction

Cities play an important role in the implementation of the 2030 Agenda for Sustainable Development and in the achievement of the Sustainable Development Goals (SDGs). Local governments are close to the citizens and are responsible for the development and provision of essential infrastructure and services for them. Most recently, local governments have been at the forefront of addressing the challenges posed by the COVID-19 pandemic. Many cities across the UNECE region have documented their progress towards the SDGs by developing **Voluntary Local Reviews (VLRs).**

VLRs provide an assessment of the progress towards achieving the SDGs at the local level. They increase the ownership of SDGs at this level and improve the engagement of local governments in the preparation of the **Voluntary National Reviews (VNRs)** and other national processes for the implementation of the 2030 Agenda. To support the cities in their efforts and to enhance the dialogue between the VLRs and VNRs, the United Nations Department of Economic and Social Affairs (DESA) has developed a set of Global Guiding Elements for VLRs that draws from the Secretary-General's common voluntary guidelines for the VNRs¹.

The VLRs are therefore an important tool to support economic and social recovery from the COVID-19 pandemic. To do this even more effectively, the VLRs need to transform from being merely a tool for reviewing the progress of achieving the SDGs to being a forward-looking and action-oriented instrument promoting sustainable and resilient urban development, mobilizing stakeholder support towards the collaborative implementation of city actions, and aligning the use of local finances with the SDGs and towards recovery from the COVID-19 pandemic.

Cities and international organizations, including the United Nations agencies, have developed tools to promote urban resilience and to overcome the negative consequences of the pandemic. For instance, the five UN Regional Commissions, UN-Habitat and the UN Capital Development Fund are providing support to 16 cities globally in the development of their immediate response and recovery plans to the COVID-19 pandemic, through the project on "Building Urban Economic Resilience during and after COVID-19". However, this and other projects and initiatives are not always well coordinated with the development of VLRs.

The theme of the 2021 Regional Forum on Sustainable Development is "Sustainable and resilient recovery from the COVID-19 pandemic and action and delivery on the 2030 Agenda for Sustainable Development in the UNECE Region". This pre-meeting to the Regional Forum will discuss how the VLRs could more
