First meeting online, 16 November 2020

Meeting Report

Mr. Gianluca Sambucini, Acting Chief, UNECE/FAO Forestry and Timber Section provided opening remarks.

Item 1 Adoption of the agenda

Agenda was adopted without changes.

Item 2 Election of Team Leaders

The Team and the secretariat thanked the outgoing Team Leaders for their contribution. A special thanks was addressed to Mr. Diarmuid McAree and Mr Josef Herkendell for their long-standing and important contributions to the work of the ToS. Ms. Carmen Aviles (Spain) was elected as Team Leader, Mr. Andreas Bernasconi (Switzerland) and Mr. Fredrik Silfwerbrand (Sweden) were elected Deputy Leaders. The Team and the secretariat congratulated newly elected Leaders.

Item 3 Briefing from the COFFI session

The secretariat presented decisions of the seventy-sixth session of COFFI which took place on 4-6 November 2020. ToS members expressed their disappointment with the possibility of discontinuation of the Team. The ToS members were convinced, that forest workforce and green forest jobs strategies are key factors to overcome the expected future challenges facing the forest sector. The secretariat proposed to share the link to the results of the Strategic Programme Review (https://www.unece.org/index.php?id=54660). The secretariat recommended the Team to continue their work as planned and encouraged it to explain how it contributes to the UNECE/FAO Programme of Work during the next session of the Joint Working Party. The Team decided to prepare a policy brief and a presentation concerning the future of the forest workforce for the next session of the Joint Working Party.

Item 4 Update on the work of the taskforce

Mr. Peter Poschen presented the work of the Taskforce and the planned approach to the visualization of the Guidelines. The ToS supported the proposed outline and procedure and integrated these activities in the list of activities of the ToS. The Team Leader informed participants that she would send a request for inputs to all team members, attaching the note describing the expected inputs.

Item 5 Finalisation of the list of activities

The Team discussed addition to the following activities to the draft list: Team meeting in February and towards the end of 2021; preparation of a policy brief and a presentation about the future of the forest workforce for the Working Party session in March 2021; elaboration and publication of visualization examples (see Agenda Item 4). The Team adopted the list of activities with these changes.





Item 6 Time and place of the next meeting

The Team agreed to hold the next online meeting in February. The exact date will be confirmed in due time

Item 7 AOB

Mr. Andreas Bernasconi thanked the team-members, the former Co-Leaders and the secretariat to their contribution and their initiative. He said that the development of the forest workforce is an important basis for the future development of the sector.
