II. Annotations to the provisional agenda

1. Adoption of the agenda

1. The Implementation Committee under the Convention on Environmental Impact Assessment in a Transboundary Context and its Protocol on Strategic Environmental Assessment will be invited to adopt the agenda for its thirty-seventh session, as set out in the present document. The provisional agenda was prepared by the secretariat in agreement with the Implementation Committee Chair, in accordance with rule 9 of the Implementation Committee's operating rules (ECE/MP.EIA/10, decision IV/2, annex IV, as amended by decision V/4 (see ECE/MP.EIA/15)).

2. Follow-up to decision VI/2

2. Discussion under agenda item 2 will not be open to observers unless the Committee decides otherwise, further to rule 17 of the operating rules.

3. The Committee is expected to follow up on decision VI/2 of the Meeting of the Parties to the Convention (see ECE/MP.EIA/20.Add.1–ECE/MP.EIA/SEA/4.Add.1) with regard to actions to be taken by Belarus and Ukraine.

4. In particular, on the basis of information provided by these Parties with regard to their implementation of decision VI/2, in preparing its report to the Meeting of the Parties the Committee is expected to deliberate on its evaluation of and recommendations regarding the following items:

(a) The steps taken by the Government of Ukraine to comply with its obligations under the Convention in relation to the Danube-Black Sea Deep Water Navigation Canal in the Ukrainian sector of the Danube Delta (Bystroe Canal Project);

(b) The follow-up by Ukraine in respect of the extension of the lifetime of the Rivne nuclear power plant;

(c) The steps undertaken by Belarus and Lithuania with regard to the construction of the Ostrovets nuclear power plant.

3. Submissions

5. Discussion under agenda item 3 will not be open to observers, unless the Committee decides otherwise, further to rule 17 of the operating rules.

6. The Committee will examine any submissions by Parties received since the Committee's previous session.

4. Information gathering

7. Discussion under agenda item 4 will not be open to observers, unless they are invited by the Committee to participate.

8. Taking into account the deliberations at its thirty-sixth session (Geneva, 5–7 September 2016), the Committee is expected to continue consideration of the information it has gathered regarding the extension of the lifetime of the Borssele nuclear power plant in the Netherlands; the planned activities by Bosnia and Herzegovina concerning the Ugljevik and Stanari thermal power plants; and the planned extension of the lifetime of the Doel and Tihange nuclear power plants in Belgium. Subject to the availability of time, the Committee will examine information submitted by five non-governmental organizations regarding the extension of the lifetime of the Dukovany nuclear power plant in Czechia, and information submitted by one non-governmental organization regarding the extension of the lifetimes of the Rivne, South Ukrainian, Zoprizhia and Khelmnitskiy nuclear power plants in Ukraine.

9. Time permitting, the Committee is also expected to continue consideration of the information-gathering cases regarding compliance with the provisions of the Protocol in relation to the adoption by Serbia of its energy strategy and energy plan and in relation to Armenia's Government programme, which seemed to set the framework for future activities in the energy field.

5. Review of implementation

10. The Committee is expected to continue its consideration of the general and specific compliance issues identified in the fourth review of implementation of the Convention (ECE/MP.EIA/2014/3) and the first review of implementation of the Protocol (ECE/MP.EIA/SEA/2014/3). In particular, the Committee will continue its consideration of the specific issues regarding compliance by the European Union with the Protocol and, if time permits, by Cyprus with the Convention.

6. Preparations for the next sessions of the Meetings of the Parties

11. The Chair will report on the outcome of the sixth meeting of the Working Group on Environmental Impact Assessment and Strategic Environmental Assessment (Geneva, 7–10 November 2016). In accordance with its structure and functions and procedures for the review of compliance (see ECE/MP.EIA/6, decision III/2), the Committee is expected to discuss preparations for the seventh session of the Meeting of the Parties to the Convention and the third session of the Meeting of the Parties to the Convention serving as the Meeting of the Parties to the Protocol (Minsk, 13–16 June 2017), particularly the drafting of decisions on the review of compliance of the Convention and the Protocol and the preparation of the Committee's report on its activities.

8. Presentation of the main decisions taken and closing of the session
