Survey on the 2022-2024 PoW – process

Online survey:


- Developed to collect suggestions & expectations from countries and partners to inform the development of the 2022-2024 POW.
- Available in 4 languages (English, French, Russian and Spanish).
- Sent to Parties, non-parties, organizations, partners, universities. Answers collected by 18 December 2020.
- Its structure was based on the current POW 2019-2021 & its 7 programme areas.
- Proposed activities were identified from (1) Discussion at intergovernmental bodies (2) Proposals by lead Parties & partners (3) needs identified through reporting under the Convention and on SDG indicator 6.5.2


The respondents were invited:

- to select the programme areas of interest for their country/organization
- to indicate the level of priority for each activity proposed for the selected programme areas
- to propose additional activities, if any
- to answer several open questions.


TOTAL of 73 complete answers were received. 69 answers were considered in the analysis (few countries submitted two answers).

PARTIES ANSWERS TO THE SURVEY






Overview of responses received:

Analysis of number of responses by programme area	Number of responses for each PA
Programme Area 1 – Support to implementation and accession	50 (72% of respondents)
Programme Area 2 – Data exchange and monitoring	60 (87% of respondents)
Programme Area 3 – IWRM at all levels	61 (88% of respondents)
Programme Area 4 – Climate change	59 (86% of respondents)
Programme Area 5 – Financing cooperation	57 (83% of respondents)
Programme Area 6 – Reporting	52 (75% of respondents)
Programme Area 7 – Partnerships and communication	55 (80% of respondents)

Survey consideration and analysis

- Medium response rate; answers by countries (Parties and non-Parties) were given a higher weight
- Generally high support to most proposed activities but had to make some choices
- High interest in basin level activities, but need to consider our mandate, capacities and added value
- More interest in regional activities and less in global ones, but need to consider our nature
- Less interest in publications updates but need some for visibility
- Covid considerations: more virtual events in the future, more online formats such as courses, web platforms etc.
- Need to follow requirements from UNECE/ UN side, eg clear mandates
- Work programme should remain flexible and adaptable however
- Some activities have to be continued from previous MOP decisions e.g. Implementation Committee (area 1.4) and reporting (area 6)
- Certain new aspects need to be included now such as gender due to UN and donor requirements

Approach for the programme of work for 2022-2024

- ❖ Overall vision: transboundary waters worldwide are managed in cooperation between riparian countries to promote sustainable development, peace and security
 - ❖ Put the PoW in a global perspective: Convention supports (Goals 1, 2, 3, 6, 7, 11, 13, 16, 17), the SDg 6 global acceleration framework as well as Paris agreement
 - ❖ The Convention has a long-term perspective, and its programme of work does too
 - ❖ The work under the Convention should respond to needs but should vary its focus over the years
 - => Continuity with change
 - ❖ Consider the Conventions global opening: now 3 Parties, soon more. Programme of work to be read together with strategy for the implementation at global level
 - Activities at different levels (national, regional/basin, global)
 - Activities under different areas supporting each others- PoW contains linkages between areas
