IPAG welcomes Jean Todt for a conference organized with the United Nations Road Safety Fund, the United Nations Development Program and the European Commission

On Tuesday 4 May 2021, the <u>IPAG Business School</u> will welcome Mr. Jean Todt, the United Nations Secretary General's Special Envoy for Road Safety, for a Kapuscinski Development Lecture (KDL) organized by the United Nations Development Program (UNDP), the United Nations Road Safety Fund (UNRSF) and the European Commission, in partnership with the <u>"Towards an Inclusive Company" Research Chair</u> of the IPAG.

The *Kapuscinski Development Lectures* are high-level conferences on development-related topics such as climate change, sustainable urban mobility, human rights, etc. They welcome world-renowned guests such as Nobel Prize winners (Esther Duflo, Joseph Stiglitz), former Heads of state or government (Michelle Bachelet, Tony Blair, Julia Gillard) or eminent development experts (Alla Murabit, Inger Andersen).

These events are promoted by the European Commission and UNDP to enable **students** from EU Member States and from all over the world to participate and learn about international development. Since the creation of the KDL, 110 conferences have been organized in renowned European educational institutions: King's College, La Sapienza Università di Roma, Trinity College, Université Libre de Bruxelles, London School of Economics ... IPAG is very honored to be the **third French establishment**, **after Sciences Po and Paris School of Economics**, **to host an event of this magnitude**.

Entitled "Safe and sustainable mobility", the next conference will have as the guest speaker, Mr. Jean Todt, former director of the Scuderia Ferrari team, and President of the Internationale Automobile Federation(FIA) and the United Nations Secretary-General's Special Envoy for Road Safety.

The purpose of the lecture will be to demonstrate that safe mobility is at the heart of sustainable and inclusive development. However, every year, 1.4 million people are killed on the world's roads and 50 million are injured. Road traffic crashes are the leading cause of death among young people (5-29) and it is developing countries that bear the heaviest burden. In addition to the enormous human suffering caused, the economic costs of road safety failures keep hundreds of millions of people in poverty.

Safe mobility is undeniably fundamental to achieve the Sustainable Development Goals (SDGs), especially those that affect health security, sustainable cities and the reduction of inequalities. With the start of the new UN Decade of Action for Road Safety (2021-2030), contextualized by the COVID-19 crisis, it is a momentous time to address our path forward.

The United Nations Secretary General's Special Envoy for Road Safety will open the lecture aimed to inspire all stakeholders, including governments, international organizations, civil society, academics, the private sector and younger generations to finally tackle one of the greatest tragedies of our time.

Additional speakers will include: Prof. Maria Giuseppina Bruna, Dean for Ethics, CSR and Social Research of IPAG Business School, Founder and Director of the IPAG Chair "Towards an Inclusive Company", Florent Menegaux, CEO of the Michelin group, Saul Billingsley, Executive Director of the International Automobile Federation Foundation and Lotte Brundum, Executive Director of the Global NGOs Alliance for Road Safety.

In accordance with United Nations General Assembly resolution 74/299 proclaiming a New Decade of Action for Road Safety, UNRSF is an innovative pooled fund, bringing together 16 private and public donors to date. Anchored in a global road action framework, the Fund has the capacity to mobilize resources to address critical gaps in national road safety systems. It is currently funding projects implemented by 11 United Nations agencies, covering 4 regions, in 19 countries. The secretariat of the United Nations Road Safety Fund is based in Geneva, under the direct responsibility of the Executive Secretary of the United Nations Economic Commission for Europe (UNECE).

About the Kapuscinski Development Lectures

The KDLs, named after Ryszard Kapuscinski, a Polish reporter and writer who has covered developing countries, are jointly organized by the European Commission, the United Nations Development Program (UNDP) and partner universities or think tanks. This lecture series offers students from European Union member states an unprecedented opportunity to learn and discuss development issues. More than 110 lectures have gathered over 30,000 participants since 2009. About Jean Todt, United Nations Secretary General's Special Envoy for Road Safety



Jean Todt was born on February 25, 1946 in Pierrefort (Cantal, France). Co-driver of rallies from 1966 to 1981, he won the team world championship that year with Peugeot. In 1982 he founded Peugeot-Talbot sports, which he managed until 1993. During these years he won 4 world rally championship titles as a team manager with the Peugeot 205 Turbo 16 (drivers and manufacturers in 1985 and 1986), 5 Paris-Dakar (from 1987 to 1991) and twice the 24 Hours of Le Mans with the Peugeot 905 (1992 and 1993). From 1993 to 2009, he is the Team Principal of the Scuderia Ferrari in Formula 1, winning 14 world championship titles (6 driver titles with Michael Schumacher from 2000 to 2004 and Kimi Räikönnen in 2007 and 8 manufacturer titles). In 2009, he was elected President of the Fédération Internationale de l'Automobile (FIA), and re-elected unanimously in 2013 and 2017. Since 2015, he has also been the United Nations Secretary-General's Special Envoy for Road Safety.

About Florent Menegaux, CEO of Michelin



After graduating with a degree in finance, management and economics, Florent Menegaux joined Price Waterhouse in 1986 as a consultant. He was soon appointed manager, specializing in interest rate risk control and management for banks.

In 1991, Exel Logistics France, a logistics and transport company, offered him the position of Finance Director. Six months later, he was promoted General Manager. From 1995 to 1996, Florent Menegaux was General Manager of the General Cargo Transport division for the Norbert Dentressangle Group.

In 1997, Florent Menegaux joined Michelin as Commercial Director for truck tires in the United Kingdom and the Republic of Ireland. In 2000, Michelin appointed him Sales Director for Truck Tires Original Equipment and Replacement markets for North America. In 2003, he became head of Truck Tires for South America.

In 2005, he was appointed head of the Africa – Middle East Zone.

In January 2006, Florent Menegaux became responsible for the Group's Passenger Car and Light Truck Tire Replacement Business Unit for Europe, before being appointed Executive Vice President for the Passenger Car and Light Truck worldwide activities, becoming a member of the Group Executive Committee, in 2008. He also oversees Michelin's Motorsports activities and Materials business.

In December 2014, he was appointed Chief Operating Officer and then Senior Executive Vice President of the Michelin Group in 2017.

In January 2018, he also supervises the Group's Business Directions, and the Manufacturing, Supply Chain and Customer Experience Operational Directions.

On May 18, 2018, Florent Menegaux is named Managing General Partner of the Group.

On May 17, 2019, Florent Menegaux is named Chief Executive Officer.

Full Professor in Management, specialist in CSR, organizational forecasting and inclusive management, Maria Giuseppina is Dean for Ethics, CSR and Societal Research of the IPAG Business School Group, where she sits on the Executive Committee. Consulted as an "Anti-discrimination, Diversity & Inclusion" expert by the French Ministries of Labor, Regional Cohesion and Higher Education, she cooperates with the OECD and, within the framework of the KDL conference, with the United Nation Found for Road Safety, the United Nations Development Program and the European Commission.

Associate Editor of Finance Research Letters (ELSEVIER) and Deputy Editor-in-Chief of Management & Social Sciences, Prof. Bruna has edited 12 special issues of classified scientific journals and published 60 academic articles on CSR, sustainable development and inclusive management.

A researcher engaged in action-by-science, Maria Giuseppina has written or directed 95 reports and has given 110 conferences and advisory missions to 50 organizations and companies in France and around the world.
