

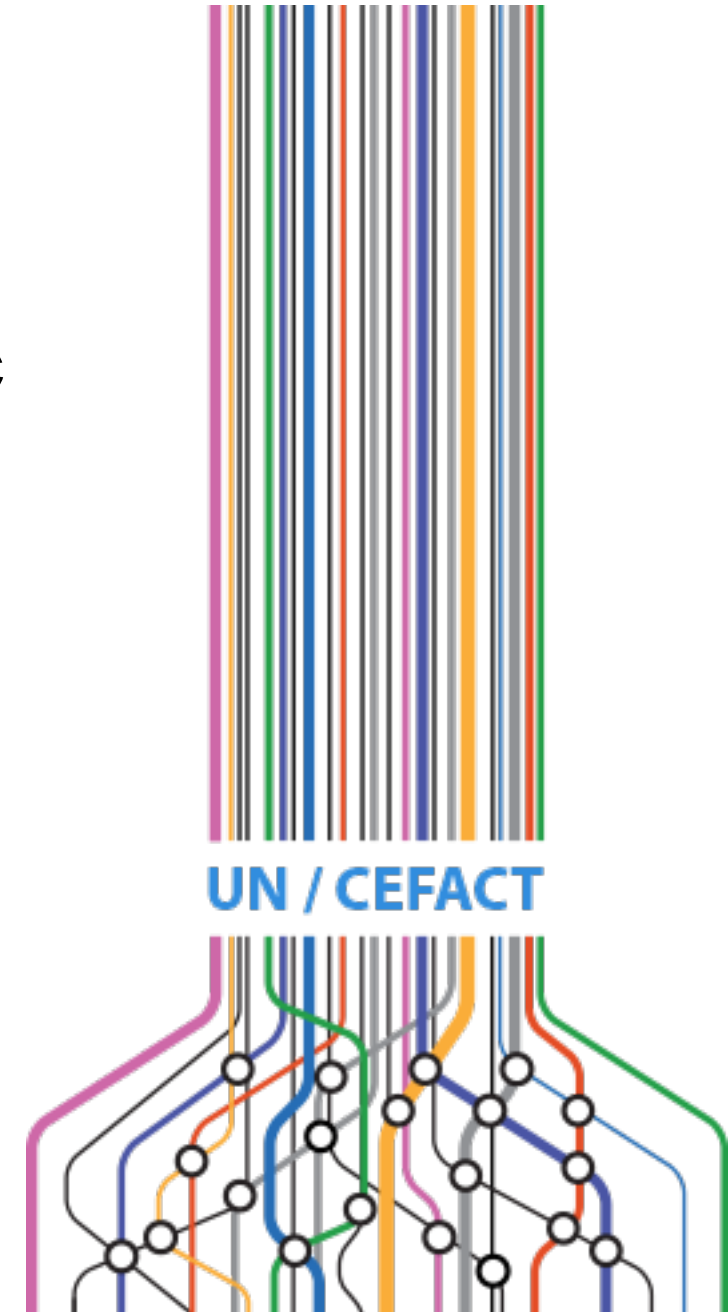

Chronology of events

June 2020

Project proposal

Project proposal was submitted in June to respond to the growing concerns with the COVID-19 pandemic

June-Aug 2020

Development

Project team established and advanced the draft through six very targeted project calls

Oct-Jan 2020/1

Public Review

In October, at the request of the secretariat Chief of Section, the text was converted from a White Paper to a recommendation and went through 60 day public review

April 2021

Final approval

Recommendation 47 was submitted to the Plenary and was approved at the 27th session on 19 April 2021.

Rec44: Cross-Border Facilitation Measures for Disaster Relief

- Concerns sudden on-set disasters
- And the first fifteen days of relief
- Outlines the key stakeholders (Annex 2), the common relief goods (Annex 3), brief description on types of disasters and their phases
- Establishes immediate response priorities
- Suggests to take into consideration readiness
- Explains how to deal with unrequested (non-priority) donations
- Provides a list of key documents on the subject (Annex 1)
