



Become a Donor of the United Nations Road Safety Fund (UNRSF)

Our ability to make a tremendous difference for road safety depends upon the continuing generosity of our contributors. International institutions, governments, non-governmental organizations, regional or local authorities and other private or public entities are invited to contribute to the UNRSF and support the Fund to save millions of lives on the road in low- and middle-income countries and reduce the number of injuries from road crashes.

The UNRSF donations are administrated by the **Multi-Partner Trust Fund (MPTF) Office**, based in New York, which acts as the Administrative Agent. The MPTFO Office is a UN center of expertise on pooled financing mechanisms which administers over 100 UN common funding instruments. It is responsible for the Fund's establishment, day-to-day financial management, the receipt of donor contributions, the disbursement of funds and the provision of the periodic consolidated report.

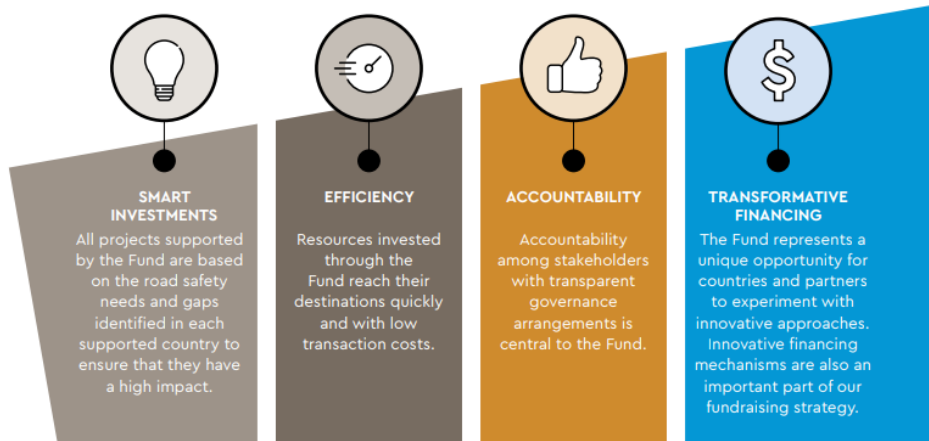
Steps to contribute to the UNRSF

If a donation is under consideration, a Standard Administrative Arrangement (SAA) for a multi-donor trust fund (MPTFs) will be prepared, reviewed and executed with the Multi-Party Trust Fund Office.</p> |
| <p>Secured wire transfer</p> | <p>The UNRSF Administrative agent, the Multi-Party Trust Fund Office (MPTFO), will contact you for information regarding the transfer.</p> <p>You may make a contribution via a direct bank wire to MPTFO. When making a transfer to the Administrative Agent, please notify the UNRSF secretariat and the MPTFO that you have made a gift to the UN Road Safety Fund.</p> |

| <p>Annual Donation</p> | <p>Donors are invited to contribute annually to the Fund thanks to an agreement between you and the UNRSF Administrative agent. An annual Donation is possible via a contract with the Fund to make fixed annual payments to the UNRSF for a period fixed in advance in the SAA.</p> |
| <p>Governance</p> | <p>Guide our work and direction by joining our governing bodies. Given there is an opening and the criteria is met there is a possibility to join the Steering Committee.</p> |
| <p>Other financial mechanisms and in kind-contribution</p> | <p>Other innovative financial mechanisms and in-kind contributions are possible within the limits fixed by the UNRSF Administrative agent and governing bodies. | <p>Welcome and Communication</p> | <p>Welcome on board! Once the SAA and transfer have been approved, the organization becomes and is recognized as an official Donor to the UNRSF.
