23rd session of the Working Group on Environmental Monitoring and Assessment

The 23rd session of the UNECE Working Group on Environmental Monitoring and Assessment was held on 4 and 5 May 2021.

Because of the online and hybrid nature of the meeting, decisions taken were subject to a silence procedure. That silence procedure was not broken by a member State, so the decisions stand.


The Working Group, among other things:

- Elected Ms. Maia Javakhishvili (Georgia) as its new Chair and Ms. Katerina Nikolovska (North Macedonia) and Mr. Johannes Mayer (Austria) as its new vice-chairs for a period of up to two years
- Adopted the report of its previous session and its timetable of activities for 2022
- Expressed appreciation to those countries supporting financially the pan-European environmental assessment – Austria, Germany, Netherlands, Norway, Serbia and Switzerland – and to the Russian Federation for its support of the present meeting
- Requested its members and the secretariat to continue their fundraising efforts to enable the full implementation of activities planned for 2021–2022, including the preparation of the pan-European environmental assessment and the holding of the next sessions of the Joint Task Force on Environmental Statistics and Indicators and the Working Group
- Adopted the final progress review report on the establishment of the Shared Environmental Information System (SEIS) in Europe and Central Asia
- Welcomed the draft elements of the next pan-European environmental assessment and took note of the

progress made, timeline and next steps for the assessment

- Requested the authors of the thematic sections of the assessment to take into account the comments made by the members of the Working Group and to focus on policy-relevant conclusions
- Encouraged member States to support preparation of the assessment with further financial contributions

The secretariat informed the meeting of the passing away on 8 April 2021 of Mr. Yuri Tsaturov, at that time Vice-Chair of the Working Group, after a long and distinguished career, including over 20 years of service to the Working Group, for many years as Chair.

- Informing biodiversity restoration policies, 26 May 2021




Figure. WHO Ambient Air Quality Database


