Objectives of the event:

- Support the Tajik authorities and operators in applying the UNECE Safety Guidelines and Good Practices for Tailings Management Facilities (TMFs) and a related TMF methodology
- Enhance the capacity of participants to reduce water-related risks from TMFs, notably by supporting them in applying the TMF checklist methodology during an on-site training
- Support Central Asian countries in the implementation of the recommendations arising from the UNECE Environmental Performance Reviews (EPRs) and the update of their national self-assessments and action plans
- Strengthen the implementation of the UNECE Convention on the Transboundary Effects of Industrial Accidents and the UNECE Convention on the Protection and Use of Transboundary Watercourses and International Lakes
- Review the progress made in the establishment of Inter-Institutional Working Groups on Tailings Safety and the Prevention of Accidental Water Pollution in Kazakhstan and Tajikistan
- Provide a forum for discussion for national authorities to improve their institutional coordination on TMF safety – among themselves, with operators and across borders.
