Work with UNECE to prepare an Action Plan to implement their tailings-related EPR recommendations


Update their Self-Assessment & Action Plan for Implementation of the Industrial Accidents Convention (countries to present)

Draft Action Plan to Strengthen Implementation of the Industrial Accidents Convention and Mine Tailings Safety (2021)

#### Introduction

Kazakhstan's 3rd UNECE Environmental Performance Review (EPR)<sup>1</sup> was developed to take stock of progress made by Kazakhstan in the management of its environment since 2008 and to provide expert recommendations for further progress. The present document was prepared to outline specific actions that Kazakhstan can take to implement several of its EPR recommendations with a focus on strengthening implementation of the Convention on the Transboundary Effects of Industrial Accidents (Industrial Accidents Convention) and strengthening mine taillings safety. The UNECE secretariat, in cooperation with Kazakhstan, formulated this action plan taking into account the country's legal obligations under the Convention, as well as existing projects, tools and guidance materials. This action plan provides concrete actions that Kazakhstan can take to implement its EPR recommendations to that effect.

#### Background

Kazakhstan acceded to the Industrial Accidents Convention on 11 January 2001. It remains the only country of Central Asia that is a Party to the Convention. The Convention aims to protect human beings and the environment through the prevention of, preparedness for and response to industrial accidents capable of causing transboundary effects.<sup>2</sup> Its measures apply to hazardous activities at, among other installations, tailings management facilities (TMFs), which are prevalent in Kazakhstan. Parties also have obligations to report on their implementation of the Convention. The country has regularly reported on the Convention's implementation, including for the:

- First reporting round (2000-2001)
- Third reporting round (2004-2005)
   Fourth reporting round (2006-2007)
- Fifth reporting round (2008-2009)
- Sixth reporting round (2010-2011)
- Seventh reporting round (2012-2013) (late submission)
- Eighth reporting round (2014-2015)
- Ninth reporting round (2016-2018) (late submission)

# Actions to implement recommendation 11.3 (a) & (b)

- Lead the organization of consultations with UNECE on the establishment of National Policy Dialogues for Industrial Safety with the subsequent signature of a respective agreement, such as Memorandum of Understanding or exchange of letters
  - By who? Ministry of Emergency Situations, Ministry of Ecology, Geology and Natural Resources and all relevant stakeholders
  - By when? December 2021
- Enhance transboundary cooperation and joint planning with neighbouring countries, including by strengthening relations with counterparts during UNECE assistance activities and by organizing meetings, drafting joint action plans and conducting exercises with them on transboundary issues, such as accidental water pollution from TMF failures
  - By who? Ministry of Emergency Situations and Ministry of Ecology, Geology & Natural Resources
  - By when? July 2022 and continuous

### **EPR** Recommendation 6.1

The Government should entrust the National Water Council to develop as soon as possible and implement a comprehensive and coherent national strategy for the integrated management of water resources. The Convention aims to protect human beings and the environment through the prevention of, preparedness for and response to industrial accidents capable of causing transboundary effects. Its measures apply to hazardous activities at, among other installations, tailings management facilities (TMFs), which are prevalent in Kyrgyzstan. UNECE has developed tools and guidance materials and facilitates assistance projects to support countries in implementing the Convention.

Several UNECE assistance projects have benefited Kyrgyzstan, including, among others:

- Project on strengthening industrial safety in Central Asia through the implementation of and accession to the Convention (2016–2019)
- Project on National Policy Dialogues for Industrial Safety in Central Asia (Phase I: Launch, ongoing)

## Actions to implement recommendation 6.1

- Identify TMFs that pose high risks for accidental water pollution, including through the application of the TMF Methodology (i.e. THI, TRI and Checklist) and, based on the risks identified, integrate mitigation measures (as per the TMF Methodology's Measure Catalogue) into the national IWRM strategy
  - By who? Ministry for Energy and Industry
  - By when? June 2022 and continuous
- Support activities to identify and map TMFs in transboundary river basins, including the Syr Darya river basin, and take measures to prevent accidental water pollution, including through the update or development of joint contingency plans
  - By who? Ministry for Energy and Industry and Ministry of Emergency Situations
  - By when? February 2022
- Ensure the Industrial Accidents Convention's prevention, preparedness and response measures are sufficiently integrated into the national IWRM strategy
  - By who? Ministry for Energy and Industry and Ministry of Emergency Situations
  - By when? April 2022

  - By who? Service for State Supervision of Safe Work in Industry and Mining, Committee of Emergency Situations and Civil Defense, Ministry of Energy and Water Resources, Ecology Committee and all other relevant authorities and bodies
  - By when? June 2021
- Improve the understanding and management of risk management of natural hazards triggering technological disasters (Natech) in strengthening tailings safety and governance, e.g. by integrating industrial/chemical hazards and risks, industrial and Natech accident prevention, preparedness and response into national disaster risk reduction strategies developed under the Sendai Framework for Disaster Risk Reduction
  - By who? Service for State Supervision of Safe Work in Industry and Mining and all relevant authorities and bodies
  - By when? December 2021 and continuous

  - Updating Uzbekistan's national legislation and policy to align with the Convention;
  - ii. Ensuring national governance sufficiently covers the prevention of, preparedness for and response to industrial accidents capable of causing transboundary effects, including through the full implementation of the Convention, and is coordinated across appropriate ministries and departments;
  - iii. Proceeding to accede to the Convention through the respective national channels.
  - By who? Ministry of Emergency Services
  - By when? the twelfth meeting of the Conference of the Parties in 2022

## Common approach across the region

## Identification

- Hazardous activities under Industrial Accidents Convention (Annex I)
- TMF mapping + inventory, including those with high risks
- Activities to identify + map TMFs in transboundary river basins

## Coordination

(in + across countries)

- Inter-Institutional Working Group on tailings + accidental water pollution
- Regular IIWG meetings, trainings sessions, events to build capacity
- Updates of joint action plans for emergencies + responses to accidents

### Natech

- Improve understandings of Natech risk management
- Create awareness on Natech risks at TMFs
- Integrate Natech hazards/risks into national DRR strategies under Sendai

## IAN system

- Ensure Points of Contact are kept up to date
- Ensure readiness to send/receive assistance requests + notification
- Participate in IAN System tests (sub-regional + UNECE biennial tests)

## Accession (not KAZ)

- Establish a sustainable process for NPDs on Industrial Safety
- Update legislation + policy
- Ensure national governance + coordination across ministries



## Next steps for countries to move forward

### **June 2021**

- After meeting, countries to review, approve, submit their documents to UNECE
- Countries to forward documents to WGI for review

### Mid-October 2021: 42nd WGI meeting

• Working Group on Implementation to discuss updated Self-Assessments + Action Plans by KAZ, KYR, TAJ and UZB and to monitor the implementation

## 2022: Subregional workshop

• <u>Countries</u> to report on progress in implementing their EPR Action Plans and updated Self-Assessments + Action Plans

### November/December 2022: CoP-12

• Central Asian countries to share progress with Conference of the Parties
