The Convention as an efficient global tool for transboundary water protection and management.



# **1. Achieving SDG goals**Efforts to achieve SDG 6 are off-track

The Convention's relevance in relation to other SDG goals and targets:

- + All the other targets of goal 6;
- + Goal 2 zero hunger;
- Goal 7 affordable and clean energy, and goal 15 life on land through, for instance, the work on the water-food-energy-ecosystems nexus;
- Goal 3 good health and well-being, through activities in cooperation with the Protocol on Water and Health;
  - Target 11.5 reducing the impact of disasters, in particular water-related disasters, and goal 13 climate action, through activities on water and climate;



and in general for goal 16 - peace, jutice and strong institutions, and goal 17 partnerships for the goals.

2. Emphasizing the benefits of the transboundary water cooperation, providing guidance on implementation on the Convention and increasing the number of parties to the Convention.

> 60 % of global freshwater flow is in transboundary basins
 > Transboundary river and lake basins – half of Earth's land
 > 40 % of the world's population live in shared basins
 > 600+ shared aquifers

  - + Data management.



## 5. Mitigation of and adaptation to climate change impacts in transboundary basins

Climate change affects water quantity, quality and ecosystems.

Water cooperation makes adaptation more effective and efficient.

Separate work area on climate change issues in the next work programme.

6. Ensuring stable and proper funding to transboundary water cooperation

Current lack of sustainable financing models
Exchanging good practices

Convention mainly funded from extra
 budgetary resources, voluntary contributions:
 In 2016-2018 only 38% of parties financed the programme work.
 26% of parties regularly contributed.
