## Briefing on the 9<sup>th</sup> session of the Meeting of Parties to the Water Convention

21 June 2021, 14:00-15:30 CET Room XXIV. Palais des Nations and virtual. via WebEx

Since more than 60% of freshwater globally flows in shared basins, transboundary cooperation is crucial for peace, sustainable development and human well-being. The Convention on the Protection and Use of Transboundary Watercourses and International Lakes (Water Convention) is a unique global multilateral environmental agreement aiming to ensure protection and sustainable use of transboundary water resources by facilitating cooperation.

The ninth session of the Meeting of the Parties to the Water Convention will take place in Geneva, Switzerland, in the form of a hybrid meeting (by the means of video conferencing and in- person participation) from 29 September to 1 October 2021. The meeting is organized by the United Nations Economic Commission for Europe (UNECE) in cooperation with the Government of the Republic of Estonia.

It will be a milestone for reviewing and accelerating progress towards achieving SDG target 6.5, discussing challenges and good practices related to the management of transboundary water resources worldwide and the role of the Convention in promoting cooperation. The high-level segment on "Water and Peace", on 29 September 2021, will focus on the contribution of transboundary water cooperation to peace, including how accession to and implementation of the Water Convention can contribute to it.

The Convention's global opening will be discussed, and the meeting will adopt the programme of work for 2022-2024 and important decisions. Several publications will be launched, for example on water allocation, developing legal frameworks for transboundary cooperation, intersectoral cooperation (nexus solutions), financing transboundary water cooperation, etc.
