- (ii) Approved Draft decision on financial arrangements (ECE/MP.PP/WG.1/2021/9), and requested the secretariat to submit the document to the Meeting of the Parties for consideration at its seventh session.

## **10.** Compliance mechanism

The Working Group:

- (i) Took note of the information provided by the Chair of the Compliance Committee and expressed its appreciation to the Chair and to other outgoing members of the Committee for their dedication and to the Committee for its valuable work;
- (ii) Took note of the information provided by the Chair of the Working Group, the secretariat and by participants.

## 11. Reporting mechanism

- (i) Took note of the information provided by the secretariat on the status of submission of national implementation reports for the 2021 reporting cycle. The Working Group called upon those Parties that failed to submit their reports, Azerbaijan, European Union, Iceland, Italy, Malta, Netherlands, North Macedonia, Portugal, Republic of Moldova, Sweden, Tajikistan, and Ukraine, to date to proceed with their submissions urgently, so as to ensure that national implementation reports would be taken into consideration during the preparation of the synthesis report;
- Welcomed the good practice of Germany of submitting their 2021 national implementation report in all three official languages of the Convention as well as of Belarus, Kazakhstan and Turkmenistan to submit it in two official languages;
- (iii) Approved Draft decision on reporting requirements (ECE/MP.PP/WG.1/2021/19), and requested the secretariat to finalise the document and submit it to the Meeting of the Parties for consideration at its seventh session;
- (iv) Took note of the information provided by participants.

# 12. Implementation of the work programme for 2018–2021, including financial matters

The Working Group:

- (i) Took note of the Report on the implementation of the work programme for 2018–2021 (ECE/MP.PP/WG.1/2021/6) and Report on contributions and expenditures in relation to the implementation of the Convention's work programme for 2018–2021 (ECE/MP.PP/WG.1/2021/7), and the information provided by the secretariat and delegations;
- (ii) Called upon the Parties to proceed with making financial contributions as soon as possible and expressed its concern over the fact that contributions are still arriving late in the year;
- (iii) Expressed appreciation for the work done by the secretariat and recognized the difficulties posed by limited and unpredictable funding.

## 13. Thematic session on genetically modified organisms

- Expressed its appreciation to the representatives of Serbia, Tunisia, the secretariat of the Convention on Biological Diversity, KROK University and European ECO Forum for their presentations and took note of the information provided;
- Encouraged Governments and stakeholders to use the recently completed Pocket Guide as informal training and learning tool to strengthen capacity in providing effective access to information and public participation in decisionmaking processes regarding LMOs/GMOs;
- (iii) Reiterated that promotion of awareness, education, transparency and effective public participation in GMO/LMO-related related decision-making is key for achievement of Sustainable Development Goals, in particular Goals 2 (zero hunger), especially targets related to food security, improved nutrition and sustainable agriculture; SDG 15 (life on land) and SDG 16 (peace, justice and strong institutions).
- (iv) Recognised that the joint efforts by Parties, the treaties' bodies and the two secretariats help supporting countries' efforts to achieve these SDGs; and that enhanced cooperation at national and international level serves Parties to both instruments
- (v) Acknowledged the importance of the following actions needed to be taken by Partis:
  - (a) Establish or enhance the implementation of effective procedures and mechanisms for effective access to information, public awareness and for enabling effective and inclusive public participation in decision-making and access to justice with regard to LMOs/GMOs.
  - (b) Continue strengthening coordination and cooperation between national focal points of the Aarhus Convention and the Cartagena Protocol on Biosafety.

No issues were discussed.

# 15. Roll call to establish the presence of Parties

The Working Group took note of the information provided by the Chair confirming the presence of a majority of Parties established through a roll call and concluding that the necessary quorum was reached with more than 24 Parties present.
