

## 2. UN Regulation No. 9 (Noise of three-wheeled vehicles)

GRBP will consider amendment proposals that were prepared by the expert from the International Motorcycle Manufacturers Association (IMMA) in order to align the 08 series of amendments to UN Regulation No. 9 with standard ISO10844:2014.

## 3. UN Regulation No. 51 (Noise of M and N categories of vehicles)

GRBP will be informed about the activities of the Informal Working Group on Additional Sound Emission Provisions (IWG ASEP) and of the Informal Working Group on Measurement Uncertainties (IWG MU).

GRBP will address proposals prepared by IWG MU that introduce measures to reduce variability.

## 6. UN Regulation No. 138 (Quiet road transport vehicles)

GRBP is invited to address a proposal that was prepared by the expert from France with the aim to clarify the interpretation of the requirements concerning the variation of the sound emitted proportionally with the vehicle speed.

## 7. Tyres

## (a) UN Regulation No. 30 (Tyres for passenger cars and their trailers)

GRBP will address an updated proposal for the new definition of "radial tyre" that was prepared by the experts from France and the European Commission. The same definition was also proposed for UN Regulations Nos. 54, 75, 106, 108 and 109.

### (b) UN Regulation No. 54 (Tyres for commercial vehicles and their trailers)

#### (c) UN Regulation No. 108 (Retreaded tyres for passenger cars and their trailers)

GRBP is invited to consider a proposal which was submitted by the experts of the Bureau International Permanent des Associations de Vendeurs et Rechapeurs de pneumatiques (BIPAVER), France and the Netherlands, in order to align the provisions for retreaded tyres with the previously adopted proposals for UN Regulations Nos. 30 and 117 and to cover all tread materials.

## (d) UN Regulation No. 109 (Retreaded tyres for commercial vehicles and their trailers)

GRBP will address a proposal by the experts of BIPAVER, France and the Netherlands, that aims to align the provisions for retreaded tyres with the previously adopted proposals for UN Regulations Nos. 54 and 117 and to cover all tread materials.

### (f) UN Regulation No. 141 (Tyre pressure monitoring system)

GRBP will address a proposal that was prepared by the Task Force on Tyre Pressure Monitoring System and on Tyre Installation (TF TPMSTI) in order to align UN Regulation No. 141 with the transitional provisions of European Union Regulation 2019/2144.
