II. Annotations

1. Adoption of the Provisional agenda

The first item to be considered is the adoption of the draft agenda.

2. Workshop: "Railways at the centre of the post-pandemic recovery – Connectivity through the railways"

The Working Party may wish to consider the workshop on "Railways at the centre of the post-pandemic recovery — Connectivity through the railways". As the recovery from the pandemic takes effect, it is important that policymakers focus their attention on ensuring that rail is at the centre of this recovery, making the most of its key role in connecting countries within and between continents. This workshop will discuss the central role of the rail sector in this recovery as well as identify how its key position in facilitating connectivity can contribute to that.

A summary of the workshop will be prepared following the session.

3. European Agreement on Main International Railway Lines

The Working Party may wish to be informed by the secretariat about its activities to increase the number of contracting parties to the European Agreement on Main International Railway Lines (AGC Agreement). Detailed information on the AGC Agreement, including the up-to-date and consolidated text of the agreement (ECE/TRANS/63/Rev.4), a map of the AGC network, an inventory of compliance with AGC standards, information on the background, benefits and accession requirements for AGC (ECE/TRANS/SC.2/2020/2) and the relevant Depositary Notifications are available on the website of the Working Party.

The Working Party may also wish to be informed about the notification of changes to the AGC agreed at previous sessions of the Working Party (ECE/TRANS/SC.2/2020/4) and notified to the depository in New York as well as new amendment proposals as set out in document ECE/TRANS/SC.2/2021/2.

The Working Party will be updated on efforts being undertaken to update the joint AGC-AGTC online tool on technical parameters for operation on the E-Rail network.

4. Towards unified railway law in the pan-European region and on Euro-Asian transport corridors

The Working Party may wish to recall that at its seventy-fourth session in November 2020, it was not able to discuss the report of the Group of Experts on Unified Railway Law. This was due to the pandemic and liquidity restrictions at the United Nations Office of Geneva which had meant that the two meetings planned for 2020 had to be postponed, one of which to January 2021. A report of this last session was prepared.

The Working Party may wish to be informed about the progress of meetings in 2020 and 2021 and discuss the next steps in preparing URL.

6. International Passenger Railway Hubs

As part of this agenda item, the Working Party may wish to recall that, at its seventy-third session, it had welcomed the adoption of the new Convention on the facilitation of border crossing procedures for passengers, luggage and load-luggage carried in international traffic by rail by ITC on 22 February 2019. 4 April 2019. The Working Party may wish to discuss next steps on this subject in light of the work being carried out in this Group of Experts.

7. Euro-Asian rail transport

Following the seventy-third session a summary publication was prepared by the secretariat and is available on the Working Party's webpage.

The Working Party may wish to be informed about and discuss new developments on Euro-Asian rail transport corridors, its involvement in developing the Euro-Asian Transport Links (EATL) project, including the results of the recent meetings on EATL and developments in relation to the "Sustainable Inland Transport Connectivity Indicators".

Following the decision of the Working Party at its seventy-second session, the Working Party may wish to be informed about developments in the Eurasian Rail Alliance Index (ERAI).

The Working Party may wish to be informed about the developments in rail security, including updates on the Rail Security Observatory and the ongoing collaboration with the International Union of Railways (UIC) on security matters.

11. Innovation in Rail Transport

In line with the ECE road map for promoting the use of Intelligent Transport Systems (ITS) that contains 20 global actions for 2012–2020 ("Intelligent Transport Systems (ITS) for sustainable mobility", 2012). The Working Party may wish to recall that at its last session it discussed document ECE/TRANS/SC.2/2019/5 prepared by the secretariat on continuing work in this area.

The Working Party may wish to recall that it agreed to the creation of a rail innovation observatory aimed at sharing with member States best practice innovations that could further help develop the competitiveness of the railways. The aim would also be to assist in achieving the Sustainable Development Goals and work towards the achievement of technology pillar of the ITC strategy. The Working Party may wish to be updated on the creation of the observatory noting that this item could not be discussed at the seventy-fourth session of the Working Party due to resource limitations on interpretation.

The Working Party may wish to recall that, at its last session, it agreed to sending f the productivity questionnaire provided in document ECE/TRANS/SC.2/2020/7. The Working Party may wish to be informed about the data gathering efforts made and the information received as contained in ECE/TRANS/SC.2/2021/2.

13. Climate Change and Rail Transport

(a) Group of Experts on Climate Change Impacts and Adaptation for Transport Networks and Nodes

The secretariat will inform the Working Party about the work of the group and especially about the work to be done which is relevant to rail transport.

(b) Climate Change mitigation and the For Future Inland Transport Systems tool

The Working Party will be informed about the developments in 2020 of the For Future Inland Transport Systems (ForFITS) project. The aim is to develop and implement a monitoring and assessment tool for carbon dioxide emissions in inland transport, including a transport policy converter to facilitate climate change mitigation. The Working Party may wish to discuss ForFITS and railways.

(c) Green logistics, eco-scoring and related matters

The Working Party may wish to be informed about developments in this area.

14. Railway Reform

The Working Party may wish to be informed about the developments on railway reform, building on the workshop held at the seventy-first session of the Working Party.

15. Facilitation of international rail transport in the pan-European region

(a) Facilitation of rail border crossings

The Working Party may wish to be informed about developments in the new annex 9 to the "Harmonization Convention" on facilitating rail border crossings in the pan-European region. The Working Party may also wish to discuss the draft survey developed by the secretariats of SC.2 and the Working Party on Customs Questions affecting Transport (WP.30) on Annex 9 (ECE/TRANS/WP.30/2021/4). This survey is to be discussed at the session of WP.30 in October 2021. Any decisions at this meeting would be communicated to SC.2 at its seventy-fifth session.

Member States may also wish to share best practices in implementing the Harmonization Convention at the session.

(b) Harmonization of technical specifications on different railway systems

The Working Party may wish to be informed by the Organization for Cooperation between Railways (OSJD) and/or the European Union Agency for Railways (ERA) about improvements in the 1,435 mm and the 1,520 mm broad gauge railway systems, and about the results of the work of the OSJD/ERA Working Group on Interoperability.

16. Rail Review

The Working Party may wish to recall that at its seventy-third session, it had discussed document ECE/TRANS/SC.2/2019/7 setting out investment-related data on projects and the mapping of this information on a GIS platform.

In line with discussions at the seventy-third session of SC.2, the Working Party may also wish to discuss developments related to the Code of Practice on the Packing of Cargo Transport Units administered by the Working Party on Intermodal Transport and Logistics.

19. Activities of Inland Transport Committee and its subsidiary bodies

The Working Party will be informed about activities of ITC, its Bureau, subsidiary bodies and other United Nations organizations on matters of interest to the Working Party.

20. Activities of the European Commission in rail transport

In line with standard practice, the Working Party may wish to be informed about recent activities and plans for the future work of the European Commission (DG Move) in rail transport.

21. Activities of international organizations in rail transport

The Working Party may wish to be informed about recent activities and plans for the future work of other international organizations and stakeholders in the field of rail transport.

22. Programme of Work for 2022–2023

The Working Party may wish to recall that at its seventy-third session it approved the document on the implementation of the ITC strategy (ECE/TRANS/SC.2/2019/2). At its seventy-fourth session the Working Party then adopted its new terms of reference adjusting its approach to reflect the implementation of the ITC strategy (ECE/TRANS/SC.2/2020/1). This document was then subsequently approved by the Inland Transport Committee. Based on these documents, the secretariat has prepared a draft programme of work for the period 2022–2023 (ECE/TRANS/SC.2/2021/3) which the Working Party may wish to consider.
