## II. Annotations

The Meeting of the Parties to the Protocol on Pollutant Release and Transfer Registers will take place on 22 October 2021, in Geneva. The Meeting of the Parties to the Convention on Access to Information, Public Participation in Decision-making and Access to Justice in Environmental Matters (Aarhus Convention) will hold its seventh session from 18 to 20 October 2021, in Geneva. The joint High-level Segment of the Meetings of the Parties to the Convention and the Protocol on Pollutant Release and Transfer Registers will take place on 21 October 2021. The approval of a report on credentials with regard to the Protocol's Parties, to be presented orally by the officers in accordance with rule 17 of the rules of procedure (see ECE/MP.PRTR/2010/2/Add.1, decision I/1, annex), and the adoption of draft operating procedures to facilitate remote participation and decision-making at the fourth session of the Meeting of the Parties to the Protocol due to extraordinary circumstances (ECE/MP.PRTR/2021/7) will take place at the joint High-level Segment under agenda item 2.

Due to restrictions associated with the coronavirus disease (COVID-19) pandemic, the fourth session of the Meeting of the Parties to the Protocol on Pollutant Release and Transfer Registers will be held in a hybrid format (combining online and in-person participation).

In addition to documents addressing particular issues or themes under specific items, two documents produced by the secretariat will provide relevant background information for many of the items to be considered in the general segment and will therefore not be repeated after each item as background documentation unless specifically under consideration. These are:

- (a) A synthesis report on the status of implementation of the Protocol (ECE/MP.PRTR/2021/10);
- (b) A report on the implementation of the work programme of the Protocol for 2018–2021 (ECE/MP.PRTR/2021/8).
