



Launch of the second Progress Report on Transboundary Water Cooperation Global status of SDG indicator 6.5.2 and acceleration needs

Concept & Agenda

1. Background and context

Over 80% of countries sharing transboundary waters engaged in the 2nd monitoring of SDG indicator 6.5.2. (2020-2021). Reporting on transboundary water cooperation has helped to highlight the importance of cooperation and started to address data gaps previously identified. However, despite the potential of transboundary water cooperation to support both "Water for All" (SDG6), and several other SDGs related to poverty, food, health, land and marine ecosystem, climate action, and peace and security, SDG indicator 6.5.2 data suggests that only 24 out of 153 countries have all theirs waters covered by operational arrangements. A major effort is therefore needed to accelerate progress.

Where arrangements for transboundary water cooperation are lacking what can countries do to address any bottlenecks they face, and accelerate progress towards making those arrangements operational? What concreate action can third parties, such as UN agencies, non-governmental organisations, academia, scientific and civil society groups, take to support countries in their efforts? Where arrangements are not operational, are there certain factors of operationality, such as the holding of regular meetings or exchanging data, that can result in 'quick wins' that accelerate achievement of the SDG 6.5 target, i.e. implementing Integrated Water Resources Management (IWRM) at all levels by 2030?

In finding answers to the questions above, the webinar will launch the 2nd Progress report on the indicator prepared in 2021 and discuss how concreate actions can be taken to accelerate progress on transboundary water cooperation in support of the SDG 6.5 target. Co-organised by the co-custodian agencies of SDG indicator 6.5.2, the United Nations Economic Commission for Europe (UNECE) and the United Nations Educational, Scientific and Cultural Organization (UNESCO), the webinar forms part of the series of webinars to launch SDG6 indicators reports in 2021 under the umbrella of UN-Water Integrated Monitoring Initiative for SDG 6 (IMI-SDG6).



2. Objectives of the webinar

This webinar aims to:

- Introduce the key outcomes, findings and recommendations of the 2nd monitoring in 2020/2021 on SDG indicator 6.5.2, thus explaining the status transboundary water cooperation worldwide;
- Show good practices in accelerating progress on transboundary water cooperation towards achieving SDG target 6.5 and identify key factors that can trigger concrete actions to reduce data gaps and to advance the adoption of operational arrangements;
- Showcase initiatives and frameworks that support the acceleration of progress on transboundary water cooperation, for example through the lenses of the 5 accelerators of SDG6 Global Acceleration Framework (https://www.unwater.org/publications/the-sdg-6-global-acceleration-framework/).
