A proposed conceptual framework for IDP Repository

Submitted by Fédération Internationale de l'Automobile

This informal document provides a conceptual framework and structure for IDP Repository originally proposed by FIA at the 82nd Session. WP.1 is invited to provide comments.

This informal document provides a conceptual framework and structure for the originally proposed UNECE IDP Repository (brought forth during the 82nd Session, March 08-12, 2021). WP1 is invited to provide comments and recommendations for additional or removal of information provided in the first draft.

This repository will be used as a risk management and authentication mechanism for IDP users. Currently, there must be governmental authorization to issue IDPs per country. However, there are numerous local, regional, and international websites issuing IDPs without proper authorization. This repository creates an available online database, hosted on the UNECE website, for any individual or local authority to research and recommend the authorized issuing body in a respective country.

The table has five columns. The table (below) is first sorted in alphabetical order A-Z by country. Secondly, each county has IDP information pertaining to which United Nations convention a country has signed with respect to the Global Forum for Road Traffic Safety. The third column provides which issuing body has been authorized to issue IDPs. The fourth column answers if a non-permanent resident with a local driver's licence may obtain an IDP from the country they are locally licensed in. The fifth column answers which IDP convention(s) a country accepts within their own borders.

^{****} Vietnam is a contracting party to the 1949 Convention on Road Traffic, but the local traffic law states that only the 1968 IDP is accepted. Club members and visitors have reported that the 1949 is accepted in practice. It has also been reported that the Vietnamese authorities require the list of contracting parties to be printed on the IDP and to include Vietnam.
