**II. Annotations**

The Meeting of the Parties to the Convention on Access to Information, Public Participation in Decision-making and Access to Justice in Environmental Matters (Aarhus Convention)

will hold its seventh session from 18 to 20 October 2021, in Geneva. The joint High-level Segment under the Meetings of the Parties to the Convention and its Protocol on Pollutant Release and Transfer Registers will take place on 21 October 2021.

Due to restrictions associated with the coronavirus disease (COVID-19) pandemic, the seventh session of the Meeting of the Parties to the Aarhus Convention will be held in a hybrid format (combining online and in-person participation).

The session will be split into a preparatory and a general segment. The preparatory segment will be held on Monday, 18 October, starting at 10 a.m. The purpose of the preparatory segment is to finalize any pending documents that may be required. Late afternoon and evening are reserved for the finalization and translation of possible revised documents and for coordination meetings. The general segment will start on Tuesday, 19 October, at 10 a.m.

Discussions on all agenda items will be held in plenary. Representatives of Parties and stakeholders with extensive relevant expertise, who can offer positive experience in furthering implementation of the Convention and addressing common challenges in relation to the items for discussion, will be invited to deliver introductory keynote statements during the general segment, opening the discussion on those agenda items.

Each agenda item, where relevant, contains a list of documents to be considered for the discussion under that item. Documents for action (for example, approval or adoption) are clearly denoted as such, while other documents intended to facilitate the discussions are labelled as background documents. In addition to documents addressing particular issues or themes, two documents produced by the secretariat will provide relevant background information for many of the items to be considered in the general segment and will therefore not be repeated after each item as background documentation unless specifically under consideration. These are:

(a) A synthesis report on the status of implementation of the Convention (ECE/MP.PP/2021/6);

(b) A report on the implementation of the work programme for 2018–2021 (ECE/MP.PP/2021/3).

In addition, individual national implementation reports, which are available from the Convention website,<sup>1</sup> may also provide useful background information for a number of the agenda items.
