### **Decisions relating to the Committee on Innovation, Competitiveness and Public-Private Partnerships**

#### *Background*

1. At its fourteenth session (Geneva, 2–4 June 2021), the Committee on Innovation, Competitiveness and Public-Private Partnerships adopted the programmes of work of the Economic Cooperation and Integration (ECI) subprogramme for 2021 (as contained in the annex) and 2022 (ECE/CECI/2021/9), and requested the secretariat to submit them to the Executive Committee for approval.
2. The Committee on Innovation, Competitiveness and Public-Private Partnerships also renewed the mandate of the Team of Specialists on Innovation and Competitive Policies for an additional two years until 2023 (ECE/CECI/2021/2).
3. The Executive Committee is invited to approve:
  - (a) the programme of work of the ECI subprogramme for 2021;
  - (b) the programme of work of the ECI subprogramme for 2022; and
  - (c) the renewal of the mandate of the Team of Specialists on Innovation and Competitive Policies.

#### *Draft Decision*

4. The Executive Committee hereby approves:
  - (a) the programme of work of the ECI subprogramme for 2021, as contained in the annex;
  - (b) the programme of work of the ECI subprogramme for 2022, as contained in document ECE/CECI/2021/9; and
  - (c) the renewal of the mandate of the Team of Specialists on Innovation and Competitive Policies, as contained in document ECE/CECI/2021/2, for 2022–2023.

# **Programme of work of the Economic Cooperation and Integration subprogramme for 2021**

## **Note by the Secretariat**

### **Introduction**

1. The present document sets out the programme of work of the Economic Cooperation and Integration subprogramme (“the subprogramme”) for 2021. The Committee on Innovation, Competitiveness and Public-Private Partnerships (“the Committee”) is invited to adopt it and to recommend it to the Executive Committee (EXCOM) for approval. Any subsequent additional, discontinued or carried-over outputs will be reflected in the Umoja tool used by the Secretariat for planning, monitoring and reporting on the implementation of the programme.

2. The programme of work applies a results-based management (RBM) approach, a broad management approach which establishes logical relationships between the hierarchical results (deliverables – objectives – impact) known as ‘results chain’, the resources (human and financial) known as ‘inputs’, and the external factors (strategic, governance, operational, financial) which can prevent the objective from being achieved.

3. The objective, the most significant planned result and the deliverables in the programme of work correspond to those contained in the ECE proposed programme budget for 2021. The objective of the subprogramme is aligned with the Sustainable Development Goals (SDGs). In attaining its objective, the subprogramme builds on cross-sectoral collaboration with other subprogrammes in relevant ECE nexus areas where multiple SDGs converge.<sup>1</sup> This type of collaboration enables the subprogramme to maximize existing synergies, increase the efficiency of its work and have a multiplying effect on the impact of its actions to support countries to implement the SDGs. The deliverables of the subprogramme fall into the following main categories: (a) facilitation of the intergovernmental process and expert groups; (b) generation and transfer of knowledge, including technical cooperation projects, training events, seminars, workshops, and publications; (c) other substantive deliverables, and (d) communication deliverables.

4. The details of the proposed publications are provided in Annex I. The overall ECE legislative mandates and those specific to the subprogramme are listed in Annex II.

## **I. Objective**

5. The objective of the subprogramme is to strengthen innovation, competitiveness and Public-Private Partnerships policies in the ECE region.

## **II. Strategy**

6. The responsibility for the subprogramme is vested in the Economic Cooperation and Trade Division.

7. The strategy of the subprogramme is based on the implementation of three core interlinked functions, namely: (a) international policy dialogue on innovation, competitiveness and public-private partnerships; (b) normative work on the same subjects; and (c) capacity-building and the sharing of best practices and lessons learned in all areas of the subprogramme’s work. This work will contribute to the ECE nexuses on sustainable mobility

and smart connectivity and on sustainable and smart cities for all ages. The subprogramme's two areas of work, innovation and competitiveness, and public-private partnerships (PPPs), are complementary. The work on innovation and competitiveness policies promotes sustainable development by supporting member States in creating a business climate that encourages and rewards innovative solutions to sustainable development challenges. The work on public-private partnerships for infrastructure development supports the same objective by promoting innovative ways of financing, building and managing infrastructure critical for sustainable development. In so doing, the subprogramme inter alia contributes to Sustainable Development Goal 9, which is to build resilient infrastructure, promote inclusive and sustainable industrialization and foster innovation, and Sustainable Development Goal 17, which is to strengthen the means of implementation, including by ensuring access to science, technology and innovation for all, and by encouraging effective public, public-private and civil society partnerships. The subprogramme also contributes to other Sustainable Development Goals where innovation and infrastructure investments are important, such as SDG 8 (sustained, inclusive and sustainable economic growth), and SDG 12 (sustainable consumption and production patterns).

8. To contribute to strengthening policies on innovation and competitiveness, the subprogramme will: (a) hold regional multi-stakeholder dialogues to identify good practices on how innovation can advance sustainable development and how Governments can support this; (b) carry out and publish analyses of national innovation policies upon request and make recommendations for policy reforms; and (c) build capacity at national and sub-regional level to implement innovation policy reforms. The work of the subprogramme will help develop a shared and improved understanding among member States on policy options available to harness the power of innovation for sustainable development, and will support national innovation policy reforms in line with international good practice and ECE recommendations. Past results in this area include: (a) the completion of an Innovation for Sustainable Development Review of Kyrgyzstan with tailored recommendations resulting in enhanced understanding of policy makers on how they can promote innovative solutions to national sustainable development priorities; (b) better innovation policies in support of national sustainable development priorities in Belarus and Kazakhstan as a result of ECE capacity building, and (c) an expanded evidence-base for innovation policy for sustainable development as a result of several new international good practices developed through ECE's international policy dialogue.

9. To contribute to strengthening Public-Private Partnerships (PPPs), the subprogramme will: (a) develop international guiding principles and standards on how to design regulatory frameworks for PPPs in various sectors and how to design PPP projects; (b) develop a methodology to assess PPP projects on whether they contribute to sustainable development ("People-first" PPPs) and certify qualifying projects on request; and (c) provide policy advice and capacity building to support member States in creating regulatory frameworks and PPP project pipelines to help close the SDG infrastructure financing gap. The work of the subprogramme will help develop a shared and improved understanding among member States and investors on how to design and operate PPPs that contribute to sustainable development, and will lead to more such projects being implemented. Past results in this area include: (a) incorporation of ECE's Guiding Principles on People-First PPPs for the SDGs into the national laws and regulations of Kyrgyzstan and Tajikistan; (b) enhanced capacity of Belarus to identify and select PPPs projects that promote sustainable development in line with ECE's People-First approach; and (c) an expanded evidence base on the implementation of SDG-compliant PPP projects in roads, railways and renewable energy as a result of international standards developed through the ECE Working Party on PPPs.

### III. Programme plan for 2021

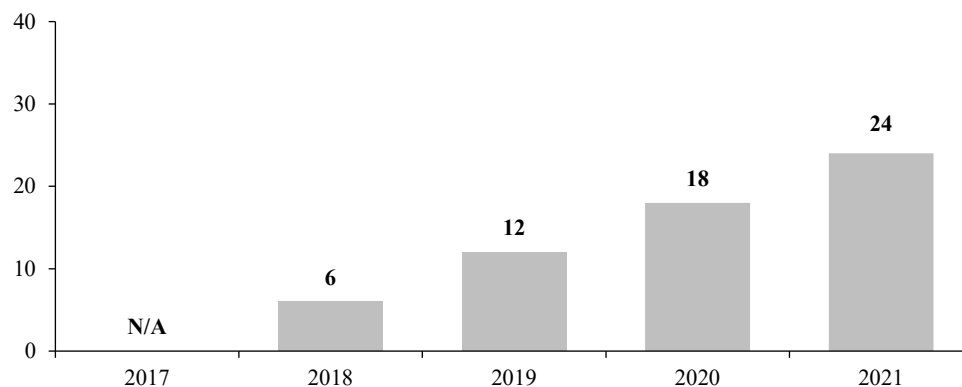
10. Result 1: Innovation policy outlook for the effective analysis of innovation policies and institutions (result carried over from 2020)

The subprogramme will continue the work related to the innovation policy outlook, in line with its mandate, and will assist countries in developing new policies that foster innovation projects for accelerated sustainable development, which is expected to be demonstrated by

the performance measure for 2021 below. For 2020, a proxy performance measure is indicated, to reflect that the General Assembly, in its resolution [74/251](#), approved a programme narrative at the subprogramme level that is composed solely of the objectives.

**11. Result 2: People-first public-private partnerships to finance sustainable development (new result)**

The subprogramme has been supporting member States in creating and improving legal frameworks and implementing regulations for PPPs as a mode to design, finance, build and operate critical infrastructure. Initially, the focus of this work had been on delivering optimal value for money. With the adoption of the 2030 Agenda on Sustainable Development, the focus was broadened to support mobilizing the enormous investments needed to achieve sustainable development. Standards, guidelines and policy recommendations were developed for so-called People-first PPPs, i.e. PPP projects that deliver not only value for money but are also ecologically sustainable and socially inclusive, for example by requiring that the projects comply with advanced noise reduction standards, or that projects provide a certain number of jobs for the local community or for socially disadvantaged groups.

*Internal challenge and response*

12. The focus of the subprogramme's work has been on developing guidelines and standards for People-first PPPs. These guidelines and standards need to be implemented in country-level projects so that they have a tangible effect in generating more PPP investments in infrastructure that support the achievement of the SDGs. The challenge is to create a framework that allows for PPP projects to be assessed against ECE's guidelines and standards in a verifiable objective way. In response, an online Project Impact Assessment Tool will be created which will allow Governments and investors to assess whether PPP projects and project proposals meet ECE's People-first criteria. ECE will further train independent evaluators, drawing on its existing network of national PPP centres of excellence, who will provide independent project assessments against the People-first criteria on request by Governments. By using a set of objective and measurable criteria developed by ECE, this initiative will help Governments design infrastructure projects that advance the SDGs. By certifying that PPP projects meet sustainability criteria, the initiative will also attract additional financial resources from developers aiming to achieve not only financial but also broader social impact.

*Expected progress towards attainment of objective and performance measures*

13. This work will contribute to strengthened policies on PPPs and their implementation as demonstrated by at least 100 PPP projects certified as complying with the ECE People-first criteria in 2021. Besides aiming to differentiate high-quality PPP projects that are fit for purpose for the SDGs from the rest, the Project Impact Assessment Tool is expected to

provide member States with real evidence on impact and performance of their infrastructure projects, which is hitherto a major lacuna. Such evidence will assist member States to prioritize investments in infrastructure projects that support progress towards achieving the SDGs; and help mobilize private finance and innovation capabilities in SDG-compatible projects.

The subprogramme is expected to achieve its objective on the assumption that: (a) there is active participation and contribution by experts from Governments, academia and the private sector to expert group meetings and networks; (b) Governments are willing to engage in policy dialogue and take measures to implement policy recommendations and standards; and (c) extrabudgetary resources for capacity-building, advisory services and field projects are adequate.
