POPULATION CENSUS METHOD FOR THE 2020 ROUND

For 2020 census round (2015-2024) Armenia is moving from traditional census method towards the register-based and combined census.

- * 100 % register based census
- * 25 % sampled census with hand-held devices


In order to update the data of the state population register in the context of the census, at the level of personal identification, they will be combined with the Border management Information System. The data on the other variables defined by the census program will be obtained by sampling 25% of the address data from the State Population Register, through interviews with the selected population by the enumerators, using tablets.

THE DATA AVAILABLE FROM THE STATE POPULATION REGISTER

- personal code;
- name, surname and patronymic, if certified documents are presented;
- > status (residence status or refugee status);
- actual registration address;
- citizenship;
- birthday, month, year, and birth place.
- > sex.

INFORMATION FROM THE QUESTIONNAIRE TO MEASURE MIGRATION FROM THE 25% SURVEYED POPULATION

Public service number



Every citizen of the Republic of Armenia is provided with a PSN


(Public Service Number).

In case of having an identification card, the person's PSN is indicated on the card, and in case of not having it, it is available on the Social Card





REGISTRATION AT THE GIVEN ADDRESS IN THE POPULATION REGISTER




The mark corresponding to the answer "Yes 1" is selected for the persons who are registered at the given address.

The mark corresponding to the answer

"No 2" is selected for persons who actually reside at the given address, but are registered at another address, or do not have a registration address at all.

COUNTRY OF CITIZENSHIP: 1st and 2nd

- For dual citizens indicate also citizenship of the second country
- * For the citizens of the Republic of Armenia indicate how the citizenship was acquired:
- ✓ From birth
- ✓ Naturalized
- **✓** Other

FOR STATELESS PERSONS

- Recognized as a refugee, deported from Azerbaijan
- Recognized as a refugee, deported from another country
- * Asylum seeker
- Undocumented stateless person
- * Unknown

AS OF THE CENSUS DAY THE RESPONDENT WAS:

- Permanently present
- * Temporary present
- * Absent

For those who are absent from the settlement or temporary present at Census day

* Duration of absence/temporary presence (months)

The reason of absence/temporary presence

- * Employment
- * Personal/family
- * Residence
- Education/training
- * Humanitarian-political reasons
- * Other

LOCATION AT CENSUS DAY

- * Absent person's location at Census day -country, in case of Armenia marz, community and settlement
- Temporary present person's location at Census day country, in case of Armenia – marz, community and settlement

LIVING CONTINUOUSLY IN THE GIVEN SETTLEMENT SINCE BIRTH: Yes/No

If "no"


- * The year/month since a person continuously lives in the current settlement
- * Previous residence country, in case of Armenia– Marz (region), community and settlement
- * Urban or rural is the settlement that person came from.

MAIN REASON OF CHANGING THE RESIDENCE:

- * From other countries as a consequence of war actions
- From other countries because of fear to be exposed to persecution for racial, national, religious belong, membership to any social group or for political convictions
- * Family
- * Residence
- * Learning
- * Job
- * Repatriation
- * Temporary protection
- Climate change
- * Other
