The decarbonization of energy intensive industries - including cement, steel and chemicals, which are responsible for over 25% of total CO₂ emissions globally - is crucial to reach net-zero CO₂ emissions.

By reducing emissions, energy intensive industries can save costs on energy and resources and become more resilient to future price or supply fluctuations. This event will explore approaches that can be taken by governments, industry and financial institutions and will launch a new UN policy brief on carbon neutrality in energy intensive industries.

Bringing together policy makers to share good practice enables the world to scale up successful business models of carbon neutral intensive industries across the UNECE region.
