# Draft annotated provisional agenda for the Ninth Environment for Europe Ministerial Conference

#### Note by the secretariat

#### *Summary*

At its twenty-sixth session (Geneva and online, 9 and 10 November 2020), the United Nations Economic Commission for Europe Committee on Environmental Policy decided to reschedule the Ninth Environment for Europe Ministerial Conference, including the Third High-level Meeting of Education and Environment Ministries (Nicosia), for 5–7 October 2022, and asked the Bureau, with support from the secretariat and in cooperation with relevant stakeholders, to prepare for the next session of the Committee a first draft of the provisional annotated agenda for the Ninth Environment for Europe Ministerial Conference.<sup>a</sup>

At its twenty-fifth session (Geneva, 13–15 November 2019), the Committee agreed on the following two themes for the Ninth Environment for Europe Ministerial Conference:


- (a) Greening the economy in the pan-European region: working towards sustainable infrastructure;
  - (b) Applying principles of circular economy to sustainable tourism.<sup>b</sup>

In addition, a high-level segment on education for sustainable development, in the form of a High-level Meeting of Education and Environment Ministries, will be organized during the Conference. Progress achieved in establishing the Shared Environmental Information System across the pan-European region will also be considered. The Conference is being organized in accordance with the Reform Plan of the "Environment for Europe" process.<sup>c</sup>

In accordance with its mandate from the Committee, the Bureau, with support from the secretariat, prepared the present document.

The Committee will be invited to consider the draft and to provide guidance to its Bureau and the secretariat in finalizing the document for the Conference.

# II. Annotations to the provisional agenda

- 1. The Ninth Environment for Europe Ministerial Conference will be held in Nicosia, from 5 to 7 October 2022. The Conference is being organized in accordance with the provisions of the Reform Plan of the "Environment for Europe" process (ECE/CEP/S/152, annex I, and Corr.1). The United Nations Economic Commission for Europe (ECE) Committee on Environmental Policy is the convening body for the preparatory process. The organizational procedures for the Nicosia Ministerial Conference, presented in document ECE/CEP/2021/7 and adopted by the Committee in 2021, serve to guide the preparations for the Conference.
- 2. The Nicosia Ministerial Conference will conduct its work under the following slogan: (TBD). The opening of the Conference may be preceded by a short greening-the-Conference-related interactive event for the heads of delegation, to be organized by the host country (TBD). During the Conference, there will be opportunities to network and organize bilateral meetings between ministers, including on topics not on the Conference agenda.
- 3. A family photograph of the heads of delegation will be taken at the end of the morning session on 5 October, between 12.30 p.m. and 1 p.m.
- 4. The detailed organization of work for the Conference is presented in document ECE/NICOSIA.CONF/2022/3 and in the annex to the present document. All documents and materials for the Conference will be made available on the ECE website dedicated to the Conference. Other information related to the Conference, including the schedule of side events organized on the margins of the Conference, will be made available on the host country website.<sup>1</sup>
