





Workshops

Four dedicated training workshops to NSB focal points in support of their respective action plans. Training will enable participants to better recognize, report and address gender inequality.



Standards Mapping

In collaboration with ITU, IEC & ISO, we will extend mapping to all 17 Goals. Utilizing Al and desk - based research to examine the technical documents.



Research

Based on survey findings, WP.6 will create training & awareness - raising material which addresses knowledge gaps & enables standards for SDGS



E-Learning Course & LMS
