Opening session: Digitalisation and ageing populations promises and pitfalls

Vitalija Gaucaite Wittich

Vitalija Gaucaite Wittich is responsible for the UNECE work in the area of population ageing and intergenerational relations. She coordinates activities of the UNECE Standing Working Group on Ageing and oversees the organization of the reviews of national policies and strategies in implementing the Madrid International Plan of Actions on Ageing in the UNECE region, capacity development and publication of policy briefs in the area of population ageing. Vitalija Gaucaite Wittich has a doctoral degree in Social sciences and before joining UNECE was an Associate Professor of Economics at Vilnius University in Lithuania.

Roxana Widmer-Iliescu

International Telecommunication Union

Roxana Widmer-Iliescu has been working in the Development Sector of the International Telecommunication Union (ITU) for over 23 years. Through her work, she contributes to achieving the overarching goal of digital inclusion by promoting the empowerment of all people through ICTs, regardless of gender, age, ability or location, including older persons.

In her capacity as the Senior Coordinator for Digital Inclusion, she advises ITU members and stakeholders on the development of ICT accessibility policies and strategies as the key element to achieve digital inclusion. To further support countries' efforts towards building digitally inclusive and age-friendly environments, she also leads the development of several ITU-D resources which raise awareness, strengthen knowledge and provide the necessary tools for implementation.

Considering that ageing is a privilege and ageing in a digital world is an opportunity, Roxana is now using her extensive experience in digital inclusion, addressing the challenges arising from two global megatrends – the rise in technology and ageing populations – to support a healthy and wealthy ageing in a digital world for the present and future older adults.

Finally, she advocates that by ensuring that technology is people-centred and ICT accessibility and Universal Design are at the top of global policymakers and decisionmakers' agendas, with appropriate partnerships and collaboration, we can jointly make the necessary changes to ensure that no one is left behind in the digital age.

Raymond Saner

Centre for Socio-Eco-Nomic Development (CSEND)

Raymond Saner is Titular Professor at Basle University, Dept. of Economics & Management since 2002 and teaches at Leuphana University, Lüneburg, Center for Sustainability (CSM), and taught at Sciences Po, Paris, Master of Public Affairs programme. His research focuses on sustainable development (UNDESA), trade and development UNCTAD/WTO), employment and poverty reduction (ILO), social economy (UNRISD), education (OECD, WTO/GATS), investment and climate change (UNCTAD, UNFCCC), and PPPs (UNECE/WHO). He was member of expert groups that drafted the Global Sustainable Development Report. Raymond Saner co-founded CSEND (1993), an ECOSOC accredited research organisation. He is co-chair of the academic network of the OECD Guidelines on Business and Human Rights and member of the UN Task Force on Solidarity and Social Enterprises. He is a Swiss delegate to the ISO WG on Active Aging and has organised panels on ICT and Ageing for the ITU/WSIS annual conference since 2018. He published 7 books, 30 co-authored books, 8 book chapters and 34 refereed journal articles. He served on the executive board of the Academy of Management ODC division and chaired its Advisory Council to the Board of Governors.

John Kiernan

Centre for Ageing Better, United Kingdom

John Kiernan is an Innovation & Change Officer at the Centre for Ageing Better in the UK, a charitable foundation the goal of which is for everyone to enjoy a better later life. The Centre for Ageing Better creates change in policy and practice informed by evidence and works with partners across England to improve employment, housing, health and communities. John's previous roles have been in ICT and digital connectivity programmes through working for the communications provider BT, in marketing and research in supporting consumers, small and medium businesses, and corporate organisations.

Eduard Mihalas

UNFPA Moldova

Mr. Eduard Mihalas is leading innovative demographic and data programmes in the Republic of Moldova as part of UNFPA, United Nations Population Fund. He led the process for shifting from "demographic security" to demographic resilience, that supports Moldovan Government in

addressing a growing ageing population, low fertility, migration of young people and low life expectancy, by promoting rights-driven and evidence-based policies. Mr. Eduard Mihalas coordinated national efforts in aligning national population data to international recommendations and practices, that result in the revision, for the first time in 30 years, of the population number at national level and estimation, for the first time, of international migration using cross-border data.

At UNFPA, he is leading the population and development portfolio. As part of this, he builds programmes that seek to establish a robust statistical system in the Republic of Moldova, promotes demographic resilience policies and engages private sector in intergenerational solidarity programmes.

Session 2: Ensuring access to essential and everyday services that move online

Biljana Radonjic Ker-Lindsay

European Bank for Reconstruction and Development (EBRD)

Biljana Radonjic Ker-Lindsay has over 20 years of international experience in leading on policies and programmes at the intersection between businesses, governments and civil society in around 40 markets in Europe, Central Asia and North Africa. Biljana is currently heading Access to Skills and Employment at the Gender and Economic Inclusion team of the European Bank for Reconstruction and Development (EBRD), based in the UK. Her work focuses on economic inclusion of youth, women, older workers, people with disabilities and other disadvantaged groups as part of Bank's investments and policy engagement.

Moreover, Natasa Todorovic is Member of the Governmental Council of Aging, the Governmental Council for Intergenerational Solidarity and President of the Gerontological society of Serbia. She is a regional representative for Europe of the International Network for the Prevention of Elder Abuse.

Milutin Vracevic

Red Cross of Serbia

Milutin Vracevic is a graduate of the Medical school of the Belgrade University, a member of the Serbian Chamber of Medicine and has a master degree in Public Health. He has worked for the Red Cross of Serbia since 2001 focusing on elder abuse and human rights of older persons. He has been active in advocacy for improved quality of life of older persons through research and closely following policies relevant for older persons at global, regional and national level including promoting the global advocacy campaign for the new United Nations' Convention on the Rights of Older People. He is one of the founders of HumanaS network and is also a Serbian co-representative in the International Network for the Prevention of Elder Abuse (INPEA) as well as a member of The Global Alliance – For the Rights of Older People (GAROP). He is a supervisory board member of the Gerontological society of Serbia and was a member of the Governmental Council of Aging from 2006 to 2013. He is a co-author of multiple scientific papers and books on different aspects of ageing, older persons' rights and quality of life.

Session 3: Safeguarding human rights in the use of digital technologies

Nena Georgantzi

AGE Platform Europe/National University of Ireland Galway

Nena Georgantzi is a lawyer specialized in human rights and social protection and an expert on the rights of older persons. She has more than 10 years of experience in the NGO sector, with a focus on strategic human rights advocacy, research and policy analysis. She is Policy Coordinator for AGE Platform Europe, the largest EU network representing older persons. Her PhD thesis was a comparative empirical study on the meaning of human rights in old age and the value of a new UN treaty. She has participated in the drafting of the Council of Europe recommendation on the rights of older persons and has consulted the UN Office of the High Commissioner for Human Rights. She is actively involved in the political process around a new UN convention on the rights of older persons and has served until recently as Deputy Chair of the Global Alliance for the Rights of Older Persons.

Vijeth Iyengar

United States Department of Health and Human Services

A cognitive neuroscientist by training, Dr. Vijeth lyengar currently serves as the Brain Health Lead and Technical Advisor to the Deputy Assistant Secretary for Aging at the Administration for Community Living (ACL), an operating division of the U.S. Department of Health and Human Services. Most recently he completed a nearly year-long secondment as a Policy Advisor to the White House Office of Science and Technology Policy where his portfolio focused on the role of emerging technologies in the areas of brain health, dementia, and neuroscience.

He serves as a co-lead coordinator of the older adult working group for the Healthy People 2020/2030 initiative and is an ex-officio member of the National Advisory Council on Aging at the National Institute on Aging. He has contributed articles appearing in the Bulletin of the World Health Organization, JAMA Health Forum, U.S. National Academy of Medicine, and Scientific American.

Dr. Iyengar was a visiting undergraduate student at Cornell University, received his bachelor's degree from Tulane University, and his masters and doctoral degrees from Duke University. He has been recognized as a Presidential Management Fellow, a National Science Foundation Graduate Research Fellow, and selected as a 2020 Aspen Ideas Festival: Health Fellow.

Verena Schriebl

Federal Ministry of Social Affairs, Health, Care and Consumer Protection, Austria

Verena Schriebl is Deputy Head of the Department "Ageing and Volunteering Policies" in the Federal Ministry of Social Affairs, Health, Care and Consumer Protection (Republic of Austria). She is UN National focal point on Ageing and the Austrian member in the UNECE Standing working group on Ageing. From 2014-2019 she worked in the Department "EU policies and coordination", where she served as Co-chair in the negotiations on the Recommendation on access to social protection for workers and the self-employed during the Austrian presidency of the Council of the European Union. From 2015-2019 she was the Austrian representative in the committee of the EU Programme for Employment and Social Innovation (EaSI) and from 2017-2019 alternate Member in the EU Social Protection Committee (SPC). becoming Director of Cooperatives Europe, the pan-European cooperative enterprise association. He eventually was appointed Director of the AAL Association in 2017.
