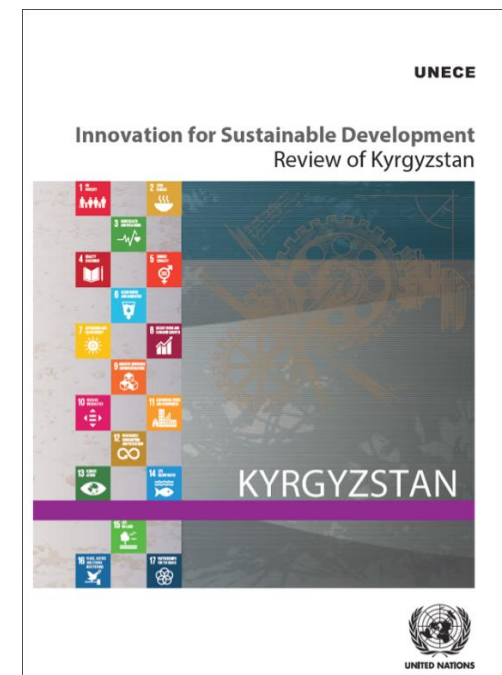

  - Stimulate innovation activity in the country;
  - Enhance innovation capacity;
  - Improve the overall efficiency of the national innovation system;
- Methods of work involves:
  - International experts;
  - Collaboration with authorities and wide involvement of local experts;
  - Elective chapters to complement core chapters.

# Innovation is a driving force for long-term sustainable development in Uzbekistan



- Significant progress in recent years, Uzbekistan has shown strong political commitment to economic reform, sustainable development and innovation policy.
- Uzbekistan is among the few countries posting positive overall growth in 2020.
- Imperative now, is to keep up this momentum and strengthen economic resilience for long-term sustainable development – to which innovation is key.
- Uzbekistan has significant, but not fully leveraged potential for innovation.
- To ensure the effectiveness of policies in place, reviewing recently introduced initiatives ahead of the new innovation strategy will be important.

# Innovation is a driving force for long-term sustainable development in Uzbekistan



- Making sure as many people try out as many new things as possible, examine what is happening, detect the opportunities and remove constraints.
- This requires maintaining efforts to create a vibrant and resilient private sector, including building absorptive capacity of private sector.
- Ensure efficient innovation policy coordination, allowing for the integration and cooperation between all policies areas that impact innovation.
- Provide effective support and sufficient access to resources and services within the innovation infrastructure to SMEs, entrepreneurs and start-ups across sectors for experimenting with new ideas for creating value.
- Develop public and private capacities and linkages to ensure knowledge transfer and technology upgrading for innovation.
