##### UNITED KINGDOM STATISTICS AUTHORITY

Ross Young is the Head of Data Governance, Legislation and Policy, and the Data Protection Officer at the UK Statistics Authority and Office for National Statistics. Ross joined the UKSA in 2008 and was previously Private Secretary to Sir Michael Scholar and Sir Andrew Dilnot as chairs of the UKSA. Before joining UKSA, Ross was a lead policy advisor and researcher on statistics legislation and statistics policy advising Members of the UK Parliament and its committees.

He is a non-executive director of the UK Statistics Authority, a member of the European Statistical Advisory Committee, a member of the Advisory Board of the ONS's Data Science Campus, and a member of the Advisory Board of the Cambridge Institute for the Mathematics of Information.
